2021 Rules for the La Grange Farmers Market

- 1. The market is a Farmers Market. Only the following items are allowed to be sold: farm and garden products, bakery and prepared food, and homemade crafts. The sale of eggs is also allowed with copies of the appropriate permit(s). The sale of meat products and/or live animals is *not* permitted.
- 2. Vendors are responsible for compliance with all requirements of the State of Texas and the City of La Grange.
- 3. All homemade items must be handcrafted by a resident of the local area.
- 4. Vendors must bring their own tables, canopies, and display racks.
 - * Refrain from using stakes for canopies or tents unless driven at a shallow angle to avoid damaging the County Courthouse's irrigation and electrical lines.
- 5. All items for sale should be marked as such with clear pricing.
- 6. Vendors will display their products in a clean and safe manner.
- 7. At the close of the market, Vendors will clean their immediate area and remove all boxes, packing materials, and trash.
- 8. Vendors should operate their business in a professional manner at all times.
- 9. Spaces on set-up day are on a first-come, first-served basis.
- 10. La Grange Main Street Advisory Board has the right to amend any and all rules without notice.
