Business transacted as follows;

PROPOSAL: FIDELITY NATIONAL BANK & TRUST CO. K.C. MO.

Moved by Councilman Swanson, Seconded by Councilman Maddox.

That we accept the following proposal; To the Hon. Mayor and Council, Concordia, Kansas. Gentlemen;- In connection with your paving program, which is estimated to cost in the neighborhood of \$ 75,000.00, we make you the following proposition:

For approximately \$ 75,000.00 legally issued paving bonds of your City, delivered to us in Kansas City, Mo. dated about Feb. 1st 1927 and to mature serially approximately one-tenth each year, said bonds to be of denomination of \$ 500.00 and/or \$ 1000.00 bearing interest at the rate of 4 1/2% per annum, payable semi-annually both principal and interest payable at the office of the State Treasurer, Topeka, Kansas- we will pay you par and accrued interest.

Pending the issuance of bonds we agree to carry approved estimates of the engineer, to be evidenced by properly issued temporary municipal notes of your city, at the rate of 6% per annum, which notes are to be retired promptly by the proceeds of the bond issue.

We agree to have our attorneys examine transcript of legal proceedings and to collaborate with your city Attorney in connection with completing the transcript, showing full authority for the issuance of bonds, and we are to pay the fees of said attorneys.

You agree to furnish us, however, promptly and prior to the issuance of bonds, a fully certified copy of the transcript showing authority for the issuance of these bonds and the regularity of the taxation provisions relating thereto, to the satisfaction of our attorneys.

We agree to prepare bonds ready for execution by your proper city officials, attend to the registration of said bonds with the State Auditor at Topeka, make necessary offering of bonds to the State School Fund Commission, as soon as the transcript proceedings are complete and ~~hereafter~~ bond ordinance passed.

In consideration of taking a definite commitment on 4 1/2% bonds at par and accrued interest, for future delivery, carrying the temporary financing on this work, and in the further consideration of performing the services above enumerated, at our expense, you agree to pay us - at the ~~rate~~ time bonds are delivered - the sum of \$ 2.39 per hundred par value of bonds so authorized.

Confirming our oral understanding of last evening while in the Council meeting, we are willing to carry a \$ 6,000. warrant of your City, the proceeds of which are to be used in making up the balance needed to retire \$ 43,000. Water Works bonds of your city maturing Feb. 1st 1927. It is understood that the warrant will draw 6% interest payable semi-annually and you estimate that you will be able to take up the warrant in about one year.

If local parties desire to purchase the warrant, it will be entirely agreeable with us, but if not, I suggest you prepare the warrant and endorse on the back thereof "presented and not paid for want of funds this _____ day of _____ 1927, and forward the warrant to us, either directly or through one of your local banks, and we will promptly remit by Cashier's check.

P.S. If you have any reluctance about issuing a warrant for the above purpose, we would just as soon carry \$ 6,000. of your past due bonds at the rate of 6% interest. Under this method you could retire \$ 1,000 bonds every two or three months. It makes no difference to us which way you handle it.

Thereupon, there comes on for consideration the petition of property owners for the special illumination of Washington Street from Third Street to Seventh Street in said City of Concordia, Cloud County, Kansas, and the Council upon motion duly made, seconded and carried does find and declare that due and legal notice has been given of the time and place of hearing of said petition all as required by chapter 141 of the laws of 1915 of the State of Kansas, and does direct the City Clerk of said City to cause such finding to be entered upon the records.

The electric light committee reported they had made investigation in regard to the petition for specially illuminating Washington Street between Third Street and Seventh Street and asked that the Council hear from Mr. Dunbar of The Kansas Power Company. Mr. Dunbar introduced Mr. Sampson, who addressed the Council. Mr. Sampson estimated the cost of such a Whiteway at approximately \$130.62, per pole or a grand total of approximately \$4,380.00, which would figure approximately \$1.88, per front foot to the abutting property owners.

additional system of street lights be constructed, installed, equipped and maintained thereon for the purpose of so specially illuminating said street.

Witnesseth; Whereas, the City has entered into a contract for the construction of a sanitary sewer approximately \$ 14,000.00 for the year 1927, which work is now being performed for which work it is necessary for the City to have ~~the same~~ funds to finance the same until bonds therefor may be issued, and

Whereas, the Trust Co has agreed to furnish the necessary funds for financing said work and take therefor temporary notes for improvement as provided by Section 10-123 the revised Statutes of Kansas, 1923.

Now therefore, it is mutually agreed between the parties hereto as follows; That the City will issue temporary notes as funds are needed for the aforesaid work, said notes to mature on or before June 6th 1928, and to bear interest at the rate of 4 $\frac{3}{4}$ % per cent and to sell the same as issued to said Trust Co and the City agrees that it will duly issue its bonds for such improvements and have same ready for negotiation and delivery on or prior to June 6th 1928, and the funds derived from the sale of such bonds shall be utilized for the purpose of taking up such temporary notes.

The Trust Co hereby agrees to, and hereby does purchase said temporary notes as issued and to pay for the same to said City upon the delivery thereof the face, plus accrued interest from date of issue to date of delivery.

As a further consideration for said temporary notes the said Trust Co also agrees that it will print for said City at its own expense

the bonds issued and made to pay for said sewer improvement and to take up said temporary notes, and will make up at its expense the necessary transcript to accompany said bonds and furnished the legal opinion of its bond attorney upon such transcript and bonds, free from charge, and deliver the same to the City office ready for execution, and as soon as executed to pay the expense of registration and return them to the City free of charge, except as hereinafter provided.

And as a further consideration for the said Trust Co for the preparing of said bonds as aforesaid, the City agrees to pay the said Trust Co the sum of One Dollar and Seventy cents for each Hundred Dollars of bonds issued as aforesaid.
