COMMITTEE MEETING MARCH 28, 1938

The Committee consisting of Mayor E. W. Powell, Councilman G. C. Gillan and City Clerk F. V. Hughes, met Monday morning March 28th, 1938, to hear objections to Nomination papers now on file in the City Clerks Office.

Proceedings of the Committee:

It was moved by Gillan, and duly seconded by Hughes and carried that the following resolution be adopted: Be it resolved that this board finds from the evidence before it that the nomination papers purporting to nominate, Z. L. Brosseau of the First Ward, R. R. Bethel, Sr., of the Second Ward, S. J. Johns of the Third Ward and W. J. Murphy of the Fourth Ward are not signed by five percentum of the qualified voters of their respective wards voting for Secretary of State at the last preceeding General Election; that written objections have been properly filed to each of said nomination paper within three days according to law; and that therefore the objections should be upheld and the names of said proposed candidates should not be printed upon the ballots at the next city election.

REGULAR MEETING APRIL 4, 1938.

The Council met in session at the City Hall Monday, April 4, 1938, at 7:30 P. M., Mayor Powell presiding with the following Councilmen present: Avery, Godfrey, Erickson, Gillan, Rhodes, Johnson, Francoeur and Peltier.

Minutes of previous meetings approved as read.

Business transacted as follows:

Upon motion and duly carried, the proposal to paint the water tower and stand pipe was tabled.

Upon motion and duly carried the matter of an audit of the City offices was left in the hands of the Ways and Means Committee with power to act.

Upon motion and duly carried, the matter of eliminating the dust coming from the streets and drives in the park was placed in the hands of the Street and Alley Committee with power to act.

Thereupon Mayor Powell nominated Mr. M. V. B. VandeMark and Mrs. Kathryn Starr to succeed themselves as members of Library Board.

Upon motion and duly carried, the above appointments of Mayor Powells was approved and confirmed.

Upon motion and duly carried, the matter of breaking the curb on the south side of Fifth Street and East from Leidigh Lumber Co., to make additional parking was left to the Street and Alley Committee with power to act.

Upon motion and duly carried, the Water Works Committee was given the power to purchase a pump for a well at the Fairground.

Upon motion and duly carried, that signs be erected on highway No. 81 designating the speed that may be maintained, after the Mayor receives the necessary information from the State Highway Commission.

Upon motion and duly carried, the Chief of Police was instructed to check up on the speeding conditions on City Streets.

Mayor Powell appointed the following councilmen to act on Bindweed committee: Avery, Gillan, Rhodes, and Peltier.

Upon motion and duly carried, the following officers reports were received and ordered placed on file: City treasurer, City clerk, Police Judge, Water Record and Fire Chief.

RESOLUTION:

WHEREAS, The Governing Body of the City of Concordia, Cloud County, Kansas, proposes to issue for the purpose of recurbing and reguttering those parts and portions aggregating 4.910 lineal feet of the intersections of the paved streets and avenues of the City of Concordia, Kansas, not abutting upon the property of private owners, and more specifically described and located in the cost estimate of curb and gutter repair made by the city engineer of said city under date of June 21, 1937, and now on file in the office of City Clerk of said city, certain bonds of said city to be dated, April 1, 1938, in the sum of approximately \$11,500.00, such bonds to bear interest at the rate of 2½ percent per annum and to mature serially from 1 to 10 years; and,

WHEREAS, The Cloud County Bank, of Concordia, Kansas, has proposed to the Governing Body of said City to purchase said issue of bonds in the sum of approximately \$11,500.00, at par and accrued interest; provided, the State School Fund Commission of the State of Kansas does not purchase said bonds, and has further provided that in the event said bonds are issued before of during the month of September, 1938, and the City, prior to the issuance thereof, is in need of funds for such recurbing and reguttering, to advance all or part of said purchase price upon the execution and delivery to it by the City Treasurer of a proper interim receipt; and,

WHEREAS, It is the desire of the Governing Body of said City that said proposal be accepted:

REGULAR MEETING APRIL 4, 1938 (Continued)

NOW, THEREFORE, BE IT RESOLVED That the proposal of the Cloud County Bank to purchase said issue of bonds at par and accrued interest, provided said bonds are not taken by the State School Fund Commission, be and the same is hereby accepted, and upon the issuance of said bonds and their rejection by the State School Fund Commission the Treasurer of the Said City be and he is hereby authorized, empowered and directed, upon the payment of the principal sum of said bonds, together with accrued interest to the date of delivery thereof, to deliver each and all of said bonds to said bank.

BE IT FURTHER RESOLVED That, in the event said City is in need of all or part of the principal sum of said bonds for the purpose for which said bonds are being issued prior to their actual issuance and delivery, the said City Treasurer be and he is hereby authorized, empowered and directed to make, execute and deliver to said The Cloud County Bank an interim receipt upon the advancement of a sum of money upon the purchase price thereof by said bank, which interim receipt shall provide in substance that upon the issuance and delivery of said bonds such advancement shall be retired by the delivery of said bonds to the Bank; but should the State School Fund Commission purchase the bonds, then such advancement shall be paid by the City Treasurer to said bank out of the proceeds of the sale of said bonds to the State School Fund Commission.
