The number of men and hours of work shall in each department be determined by the City Manager so as to be within the scope of the current year's budget. Overtime shall be compensated for by compensatory time-off. However, should the individual situation at the time warrant it, the City Manager may authorize the payment of overtime at the employee's monthly rate of pay reduced to terms of an hourly rate of pay. The Police and Fire Departments shall not receive overtime pay or compensatory time-off and shall keep regular working schedules on all holidays. The scale for these departments has been increased over and above other departments to compensate for not receiving the benefits afforded to those departments and also takes into consideration the unusual hours, unusual duties, and the greater risks that are inherent in police and fire employment.

PROBATIONARY PERIOD OF EMPLOYMENT

All new employees of the city except new department heads will serve a probationary period of at least six months before being eligible for regular status and fringe benefits of sick leave, vacations and group insurance. Advancement from probationary status to regular statutus may be made anytime following the first six months upon the recommendation of the department head and approval of the City Manager.

No fringe benefits are provided for part-time or seasonal employees.

SICK LEAVE

All officers and employees of regular standing are eligible for sick leave in accordance with the following schedule:

Such leave will be granted upon satisfactory evidence of illness given to the City Manager. The number of days of sick leave do not accumulate from year to year. The first year of regular employment begins on the closest pay day after the employee has completed his probationary period of employment and has been approved as a regular employee. No sick leave is provided for part-time or seasonal employment.

VACATIONS

All officers and employees of regular standing are eligible for annual vacations in accordance with the following schedule:

resign, be laid off, or for any reason be severed from employment with the city, the number of days the employee worked from the time he attained regular status is multiplied times .01918 to determine how many days vacation he had earned up to the time of his leaving the city. The accumulated vacation earned by an employee is to be paid to him upon his leaving the city employment regardless of the reason for his leaving the city. During the scond year or later year of regular employment, the multiplying factor is .03836 so that at the end of two years of regular employment 14 days of vacation has been earned and may be taken during the 3rd year of employment. Vacations will not accumulate from year to year. If an employee does not take his vacation during the year in which it is supposed to be taken he has lost this benefit. (Note: The year mentioned is not calendar year but regular employment year based on date employee appointed to regular status). The vacation should be taken at one time and not divided into several days off at various periods during the year. (Any alteration from this rule must have the prior approval of both the department head and City Manager).

The time which an employee desires to take for his vacation must meet with the approval of his department head and the City Manager.

No vacation time is provided for part-time or seasonal employees.

HOLIDAYS

All departments, with the exception of the Fire and Police Departments, and Sanitary Landfill operation shall receive the following holidays during the year:

New Year's Day Memorial Day Independence Day Labor Day Veteran's Day Thanksgiving Day Christmas Day

Should any one of these days fall upon a Sunday, the following day, Monday, will be observed as a holiday. Should it be necessary for an employee to work on a holiday due to an emergency or by nature of the employee's work, he shall receive compensatory time off. No seasonal, part-time, or hourly employee shall receive holiday benefits; however, should it be necessary for him to work on holidays, he shall receive his regular hourly wage.

ADVANCEMENT IN CLASSIFICATION

Any advancement in classification or pay scale must have the approval of the City Manager and will be effective on the closest pay day to the employment anniversary. No employee is eligible for advancement until at least the minimum time specified at his present classification has been completed. If no time is specified, advancement shall be at the discretion of the City Manager, but in no event shall exceed the maximum pay for the classification as contained in the current salary resolution.

OFFICERS AND EMPLOYEES TO RECEIVE ONLY ONE SALARY

A person holding more than one office or position of employment in the city government at the same time may receive the salary or other compensation of only one office or position of employment, although salaries or other compensation may be authorized for more than one of such offices or positions. Such person shall be paid the larger or largest salary or compensation provided for any such offices or positions; and if two or more salaries or amounts of compensation for any such office or positions are equal, the City Manager shall determine which shall be paid such person.

MONEY WHICH IS NOT TO BE CONSIDERED COMPENSATION

All fees, fines, penalties, costs, forfeitures, and other money, except rewards, received by an officer or employee in the exercise of his official duties, shall belong to the city, and in no case are to be considered as compensation by an officer or employee, unless otherwise specifically provided by an ordinance; provided, however, the city clerk may keep all compensation received by him as local registrar of vital statistics.

COMPENSATION OF ACTING OFFICERS AND EMPLOYEES

If a person holding office or position of employment at the same time acts in the capacity of another officer or employee, he shall not receive any salary or other compensation which may be provided for the officer or employee for whom he is acting, but shall continue to receive the salary or compensation which is provided for the office or position which he regularly held.

SUBSISTENCE AND TRAVEL EXPENSE

When authorized by the City Manager, officers and employees of the city shall be reimbursed at the following rate for expenses incurred while on official duty outside the city limits.

Mileage, 7¢ per mile Actual costs of meals, lodging, gratuities, registration, enrollment fees and banquets.

CHANGES, ALTERATIONS AND VARIATIONS BY CITY MANAGER

The City Manager in administering the affairs of the city may make exceptions or variations in the above personnel rules and regulations in those situations he feels warrant an exception or special attention.

ORDINANCE NO. 1484 METHOD FOR THE HANDLING OF THE INDUSTRIAL FUND

A discussion was held regarding the method to be used in appropriating the Industrial Fund levy. Two ordinances were considered, one ordinance would give the money to the Concordia Industrial Development Association as they requested it to be used as they deemed necessary. The other ordinance would require the Concordia Industrial Development Association to submit vouchers for their expenses to the City Clerk's office and they would be handled as other city claims are handled. That is, the vouchers would be submitted to the governing body for their approval.

The commission felt that beings the money was to be raised by taxation that they should have some control, although it was not their intent to regulate the activities of the Industrial Development Association. Therefore, the following ordinance was presented:

Commissioner Johnston moved that Ordinance No. 1484, the same being "AN ORDINANCE APPROPRIATING \$3,433.81 OF THE INDUSTRIAL FUND AND DIRECTING PAYMENT THEREOF TO THE CONCORDIA INDUSTRIAL DEVELOPMENT ASSOCIATION, INC. FOR THE PURPOSE OF INDUCING INDUSTRIES TO LOCATE WITHIN THE CITY OF CONCORDIA, KANSAS, OR NEAR ITS ENVIRONS" be placed on its passage and considered by sections. Commissioner Walker seconded the motion. Commissioner Neal moved that Ordinance No. 1484 as a whole, including its title, be passed. On roll call, the following voted "Aye": Johnston, Neal and Walker. "Nay": None.

RESIDUE SALES TAX ITS EFFECT ON THE CITY IF ELIMINATED BY THE LEGISLATURE

A discussion was held concerning the possible effect on the city's financial structure if the Governor's proposal to eliminate \$12,500,000.00 Residue Sales Tax distribution to Counties and their political sub-divisions is approved. The City Manager reported that Cloud County and its political sub-divisions would have to raise property taxes almost \$100,000.00 to offset this loss of revenue and Concordia would have to raise its property taxes by almost \$12,000.00 to offset this loss.

Also discussed was the Governor's proposal to eliminate the 2% Sales Tax exemption to contractors bidding on public works projects. The contractors would have to raise their bids and this increased cost would fall on the local taxing units, building schools, city and county buildings and other construction in the future.

After discussion, a motion was made by Commissioner Walker, seconded by Commissioner Neal and carried that in the interests of the people of Concordia that the Commission go on record and urge the legislature to continue the distribution of the Residue Sales Tax to Counties, Cities, schools and etc., and the continuation of Sales Tax exemption to contractors bidding on public projects, and State Representative Christensen and State Senator Sanborn be notified of this action.

THE CASE OF SNYDER VS CITY OF CONCORDIA REPORT BY CITY ATTORNEY

City Attorney, Clarence Paulsen, reported that on January 14, 1957, a judgment for \$7,000.00 was entered against the City by the District Court as a result of the trial held last year. The City Attorney outlined the future course of action that could be taken. The City has 60 days to decide whether to appeal this case to the Supreme Court or issue bonds and pay the judgment as soon as possible or wait and pay the judgment after the next tax levy. He also stated that interest was accumulating from the date of the judgment until paid at the rate of 6%. Should we win the appeal then the City would not have to pay the interest or the \$7,000.00.

After discussion, motion was made by Commissioner Neal, seconded by Commissioner Walker and carried that the Commission take this under consideration until the next meeting.

Mr. Joe Erickson appeared before the City Commission and requested that the \$450.00 which had been paid by his father, S. I. Erickson, on May 4, 1956, for the cost of manholes constructed on the sanitary sewer and storm sewer serving the Erickson Addition be refunded to him inasmuch as he felt that since he had provided easements at no charge back in April, 1954, it was not fair that this amount was charged in the first place.

City Manager Horn suggested that such a request should have been made in May, 1956, if he felt it was not justified and the payment by his father should not have been made.

The City Manager therefor referred to the letter which had been sent to Mr. Floyd Buckley on May 1, 1956, copies of which had been mailed to S. I. Erickson; Loren Joe Erickson; Clarence Paulsen, City Attorney; Mayor Raymond Johnston; Commissioner Calvin D. Walker and Commissioner J. L. Neal.

Quoting from item 6 of said letter the City Manager read:

"6. The City Commission has studied this problem carefully (the problem being the fact that the Ericksons had permitted the construction of a house by Mr. Buckley over the drainage and sewer easement which was recorded in the Registar of Deeds office in favor of the city) and has asked me to advise you that we need the immediate possession of our original easement and that said house must be moved to permit such access - or they have graciously consented that if you and the landowners would immediately sign an easement along the west 16 feet of Lot 1, Block A, Erickson's Addition, which comes to within approximately 1.61 feet of the west side of your house, they would accept such an exchange providing that the city is paid the additional construction costs required by not using the original easement. These additional costs which are solely needed only for the purpose of going around your house are as follows and are based on current contract prices for the sizes involved:

One	Sanitary Sewer Manhole	\$1 50. 00
Two	Storm Sewer Manholes	300.00

"If one or the other of these alternatives is exercised by you and the landowners relatively soon, there should not be any need to pursue this case any further.

Enclosed you will find a copy of the new easement needed which can be executed by all parties concerned if you decide not to move the house. Upon either the removal of the house, or the execution of the new easement and the payment to the City Clerk of \$450.00, we can proceed to complete plans on the Street work, Sanitary Sewer lines, Storm Sewer lines, and Water lines in the Erickson Addition."

The City Manager then related that Mr. & Mrs. Buckley and Mr. & Mrs. S. I. Erickson appeared in his office on May 4, 1956, and both Mr. & Mrs. Buckley and Mr. & Mrs. S. I. Erickson signed the new easement and a check was given to the city clerk in the amount of \$450.00 signed by Alma J. Erickson to pay the cost of the three manholes referred to in the letter.

The city manager then stated that inasmuch as the new easement

city been able to use the original easement the \$450.00 required would not have been necessary because the three manholes would not have been needed. He brought out in his comments that Mr. Erickson's having raised this question brought out another situation that needed action before the passage of the assessment and bond ordinances on the construction projects.

This new problem, the city manager stated, is created by the fact that the amount to be assessed for the Sanitary Sewers in Sewer District No. 14 should be reduced by the cost of the \$150.00 manhole and the \$300.00 for the Storm Sewer manholes should be subtracted from the final storm sewer bond issue amount; otherwise the \$450.00 cost of the manholes would be paid twice.

CEMETERY ENDOWMENT FUNDS
