RECREATION BUDGET INCREASE REQUEST

Five members of the Recreation Commission were present with Mr. Lee Doyen and Mr. Robert Baumann as spokesmen. Mr. Doyen emphasized the need for additional funds in the recreation program. Mr. Baumann told of the need for additional programs for the adult and elderly people of the community for a year-around program.

City Manager Kreighbaum stated that under the provisions of the state law, Concordia can levy only a maximum levy of one mill. However, the law further provides that after a recreation program has been in operation an additional one mill levy can be included in the budget by resolution of the governing body if a protest petition signed by 5% of the eligible voters at the last city election is not filed. If a satisfactory protest petition is filed, the city commission would have to submit the question to a vote of the people.

After a short discussion, Mayor Phipps told the group that the city commission would consider the request in light of the entire budget.

ANNEXATION REQUEST

The city manager presented to the commission for their consideration a request by Mr. Lloyd Barleen and sons for annexation of a 10 acre tract of land directly south and adjacent to Block 5 in Robinsons Addition.
