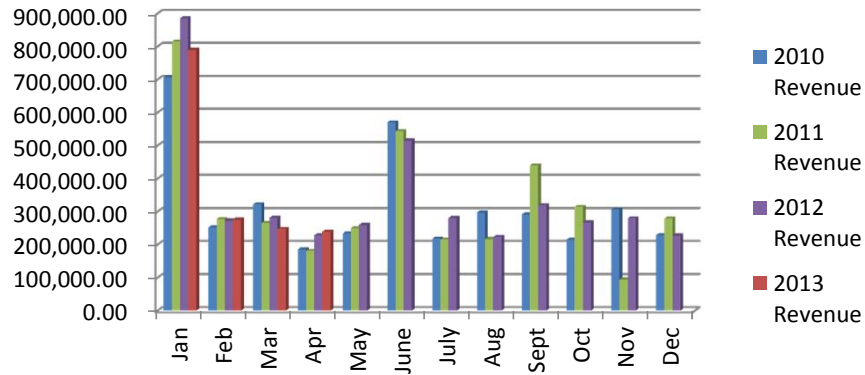

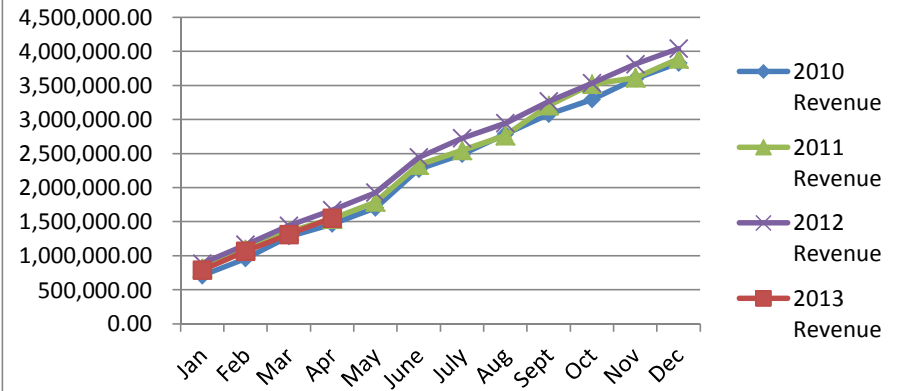

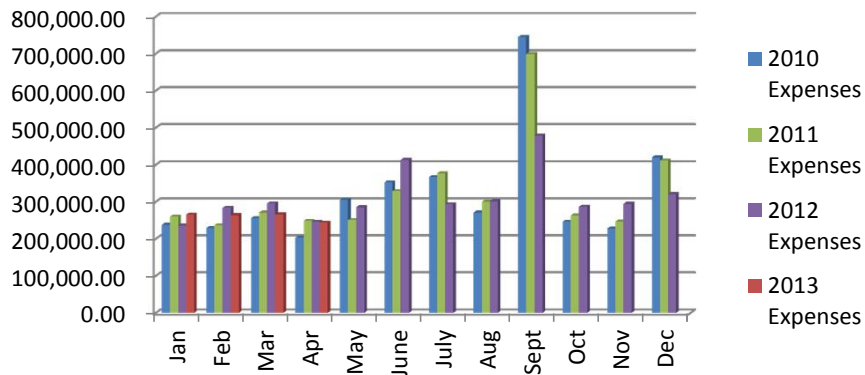
2010-2013 Revenue by Month



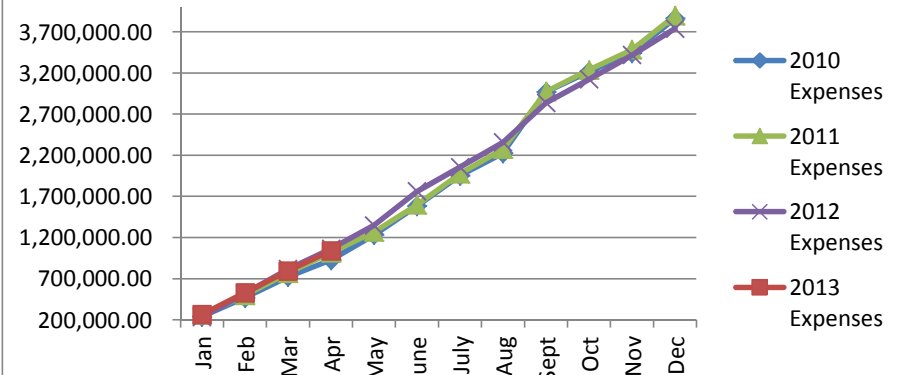
2010-2013 Cumulative Revenue



2010-2013 Expenses by Month

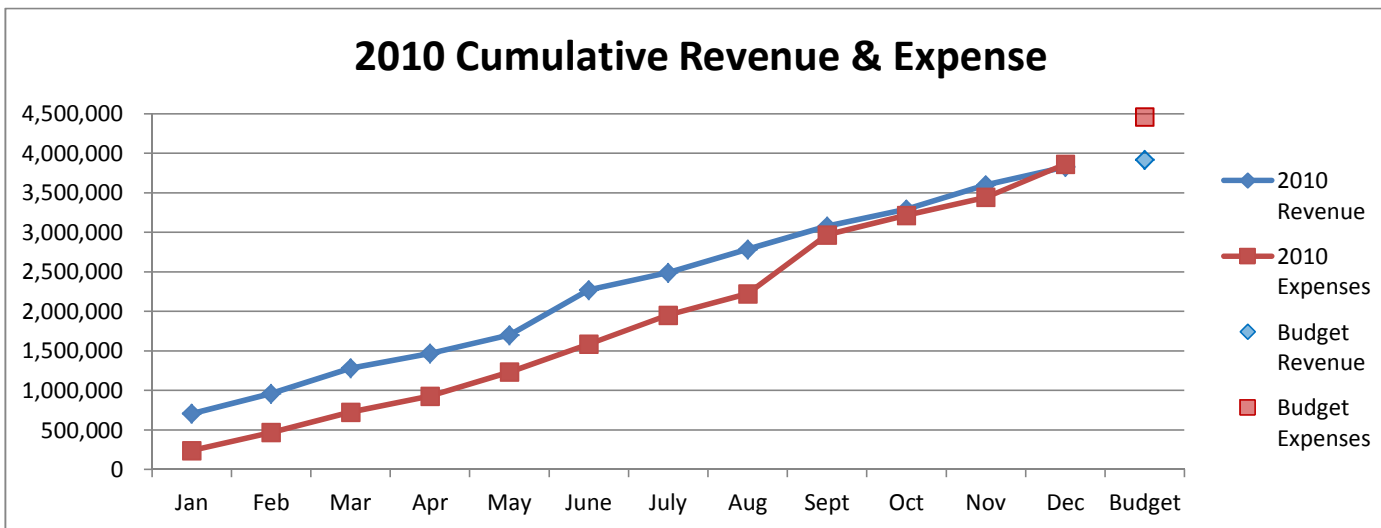
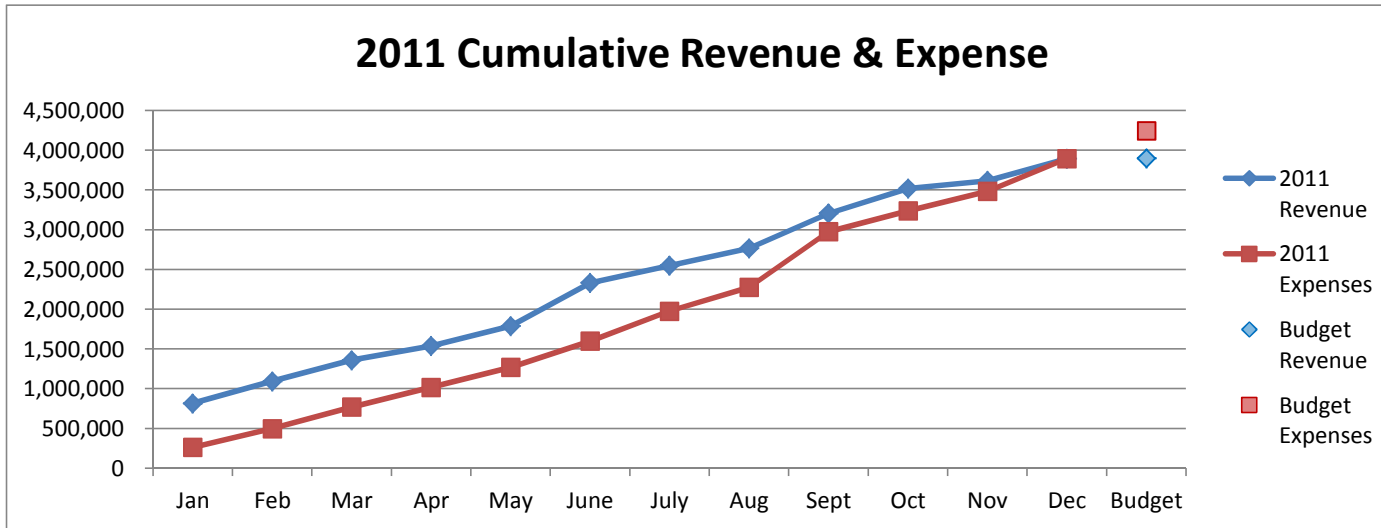


2010-2013 Cumulative Expenses

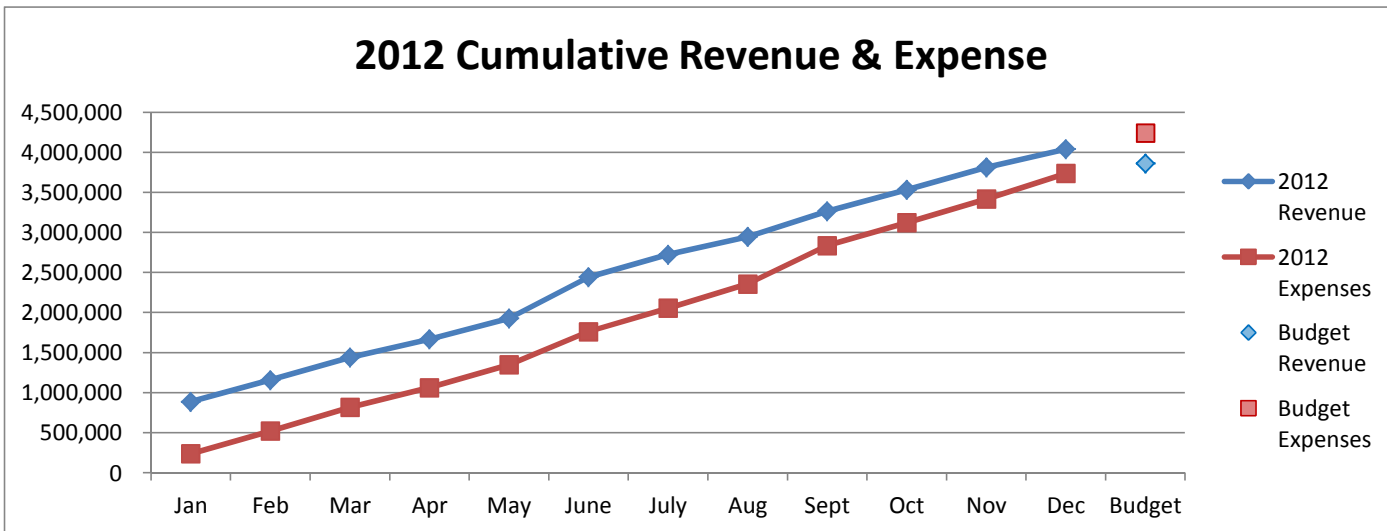
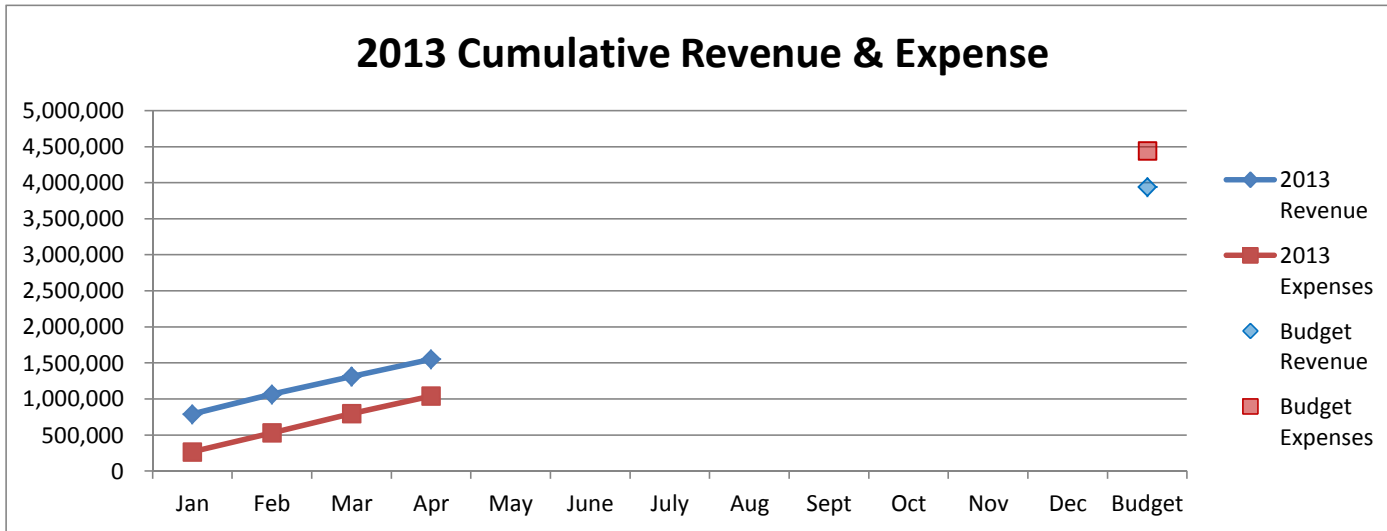

Water & Sewer Operating Fund 2010-2013

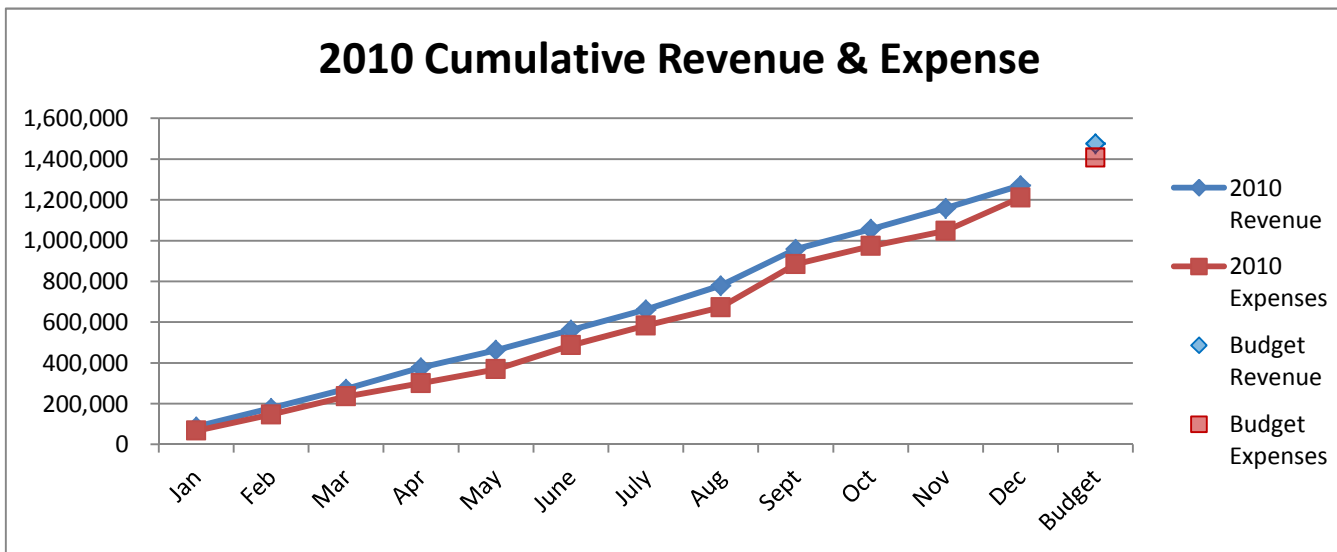
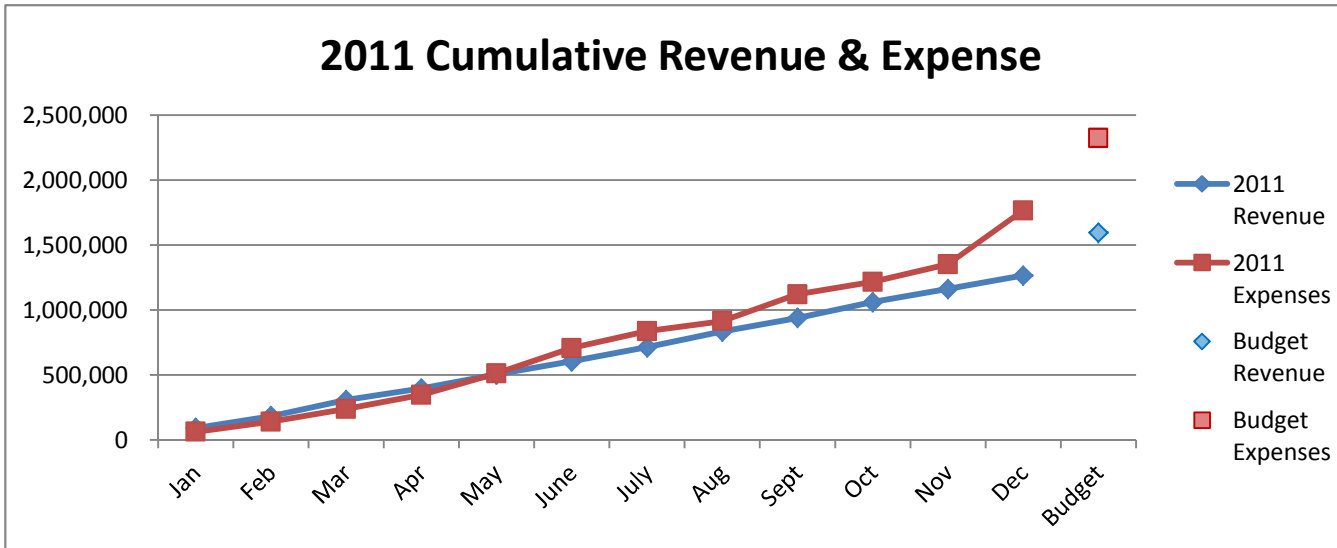

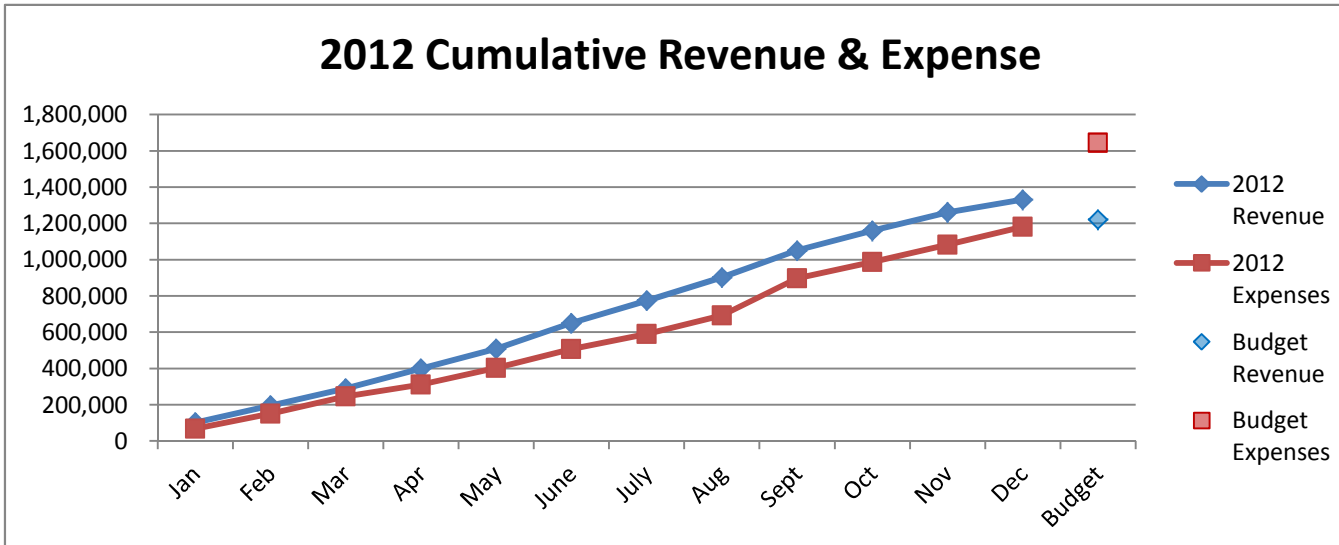
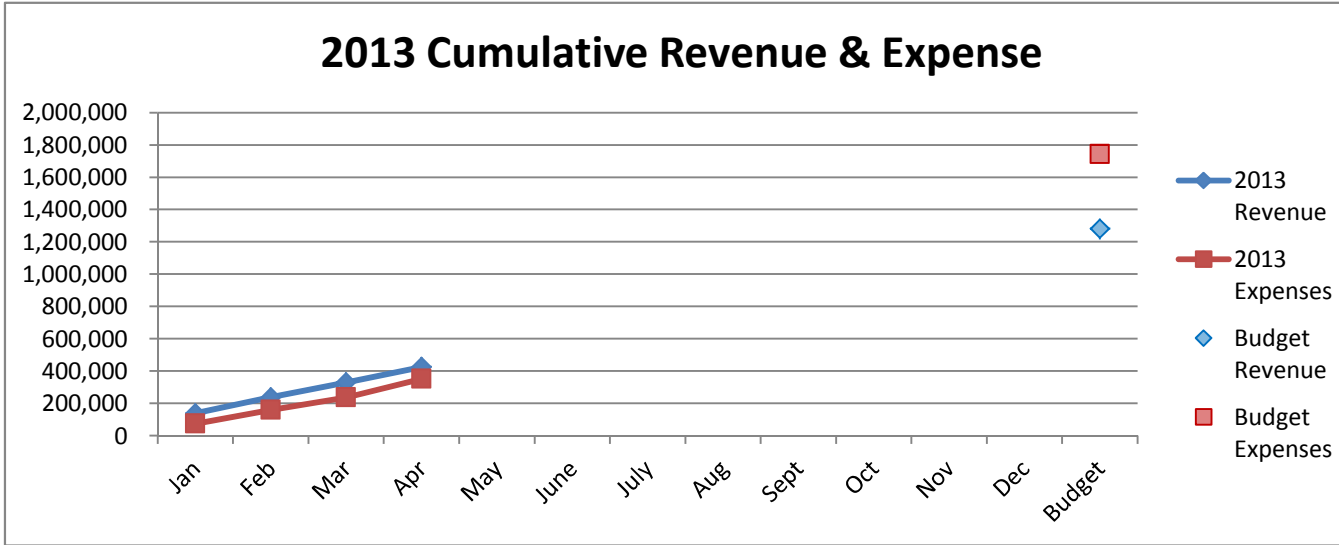
