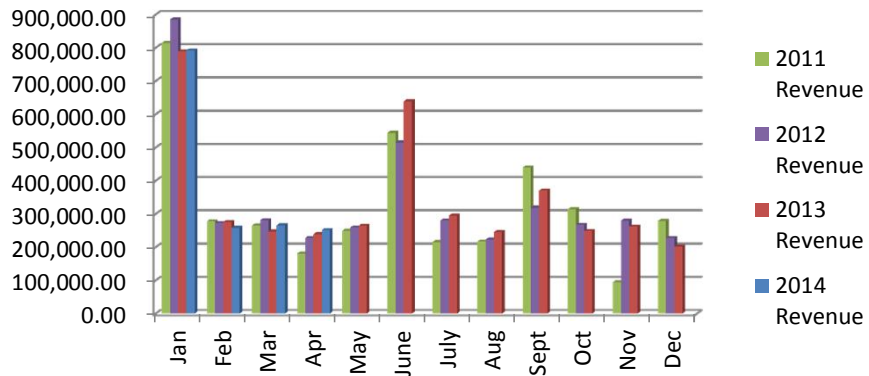

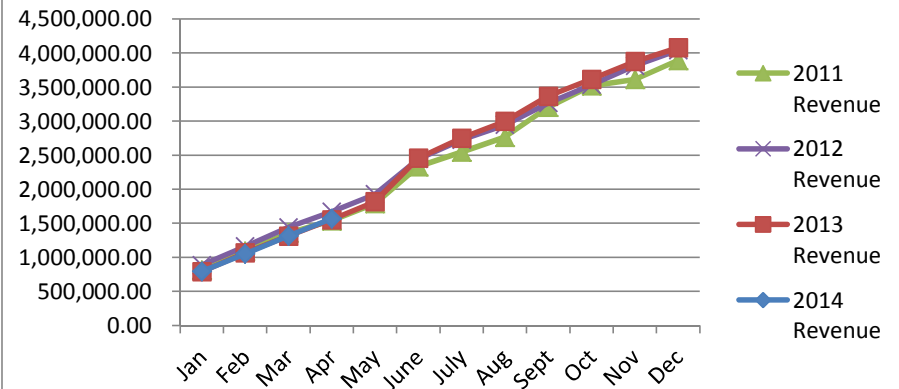

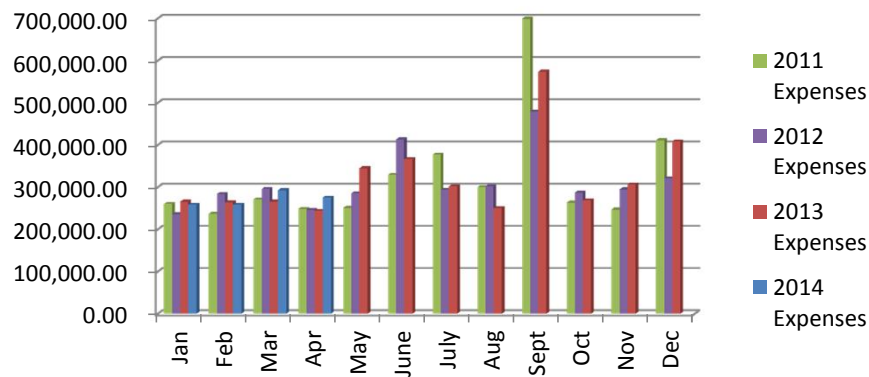
2011-2014 Revenue by Month



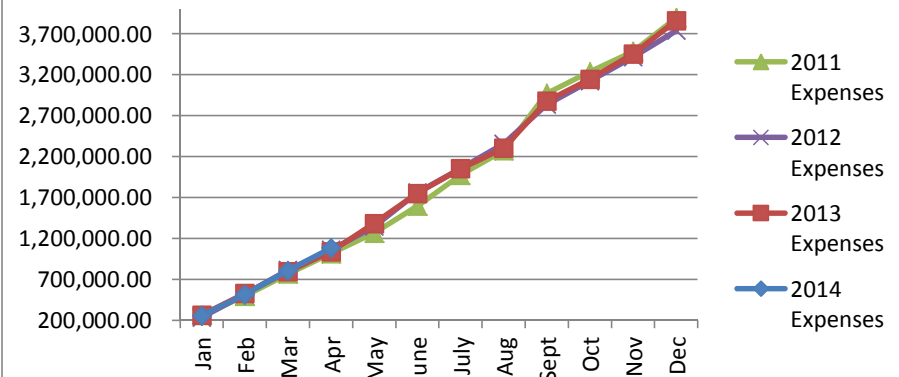
2011-2014 Cumulative Revenue



2011-2014 Expenses by Month

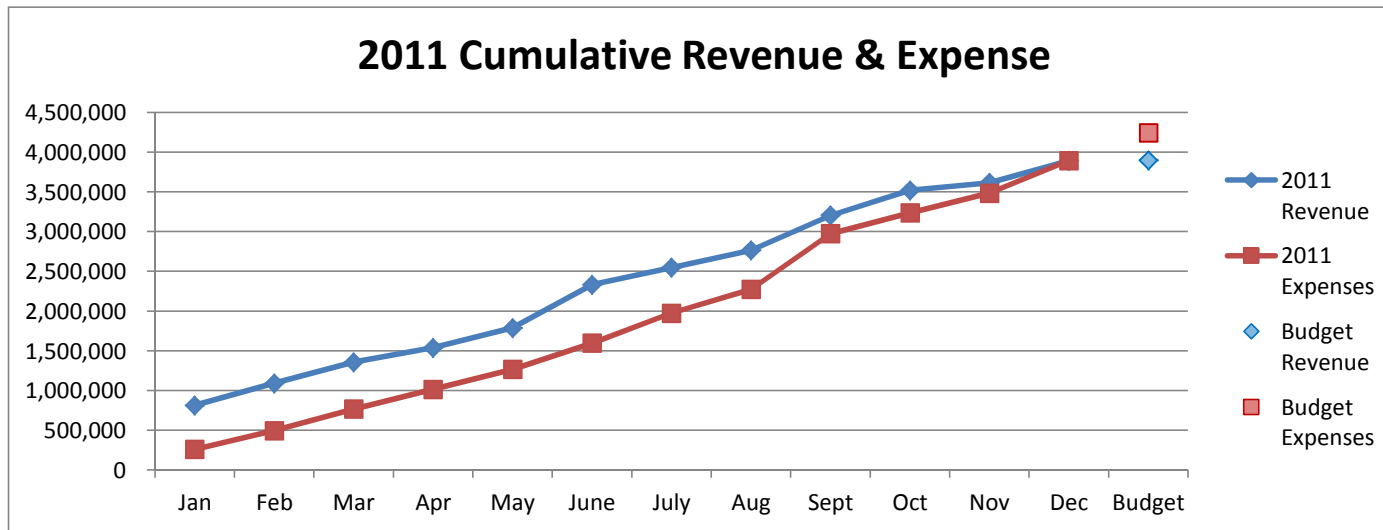
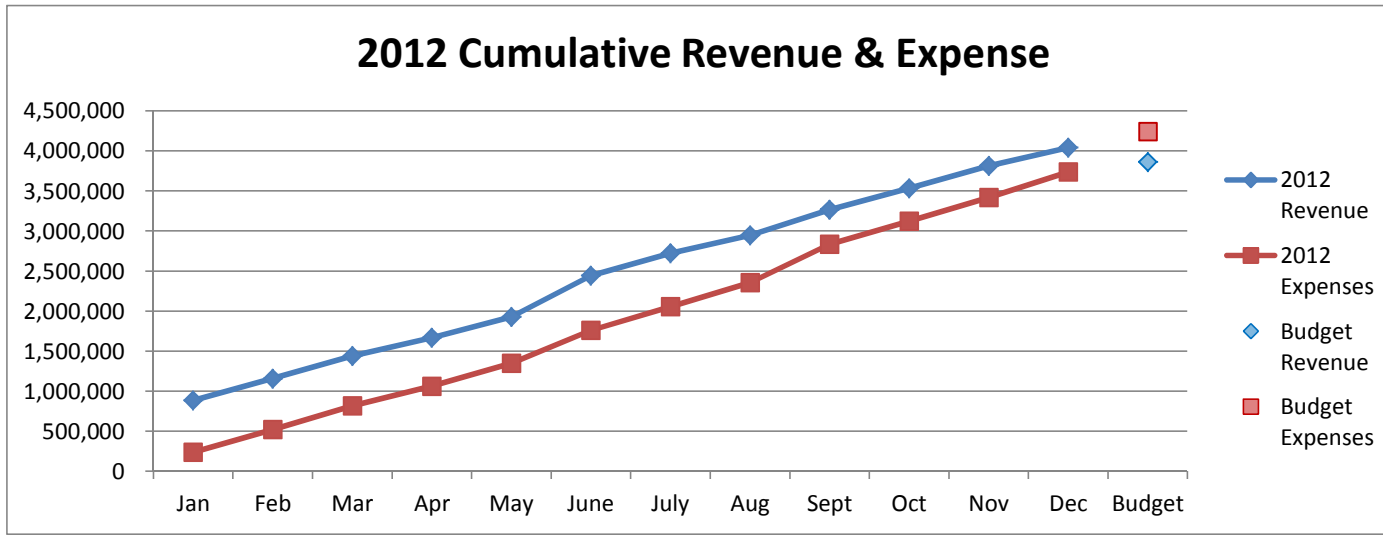


2011-2014 Cumulative Expenses

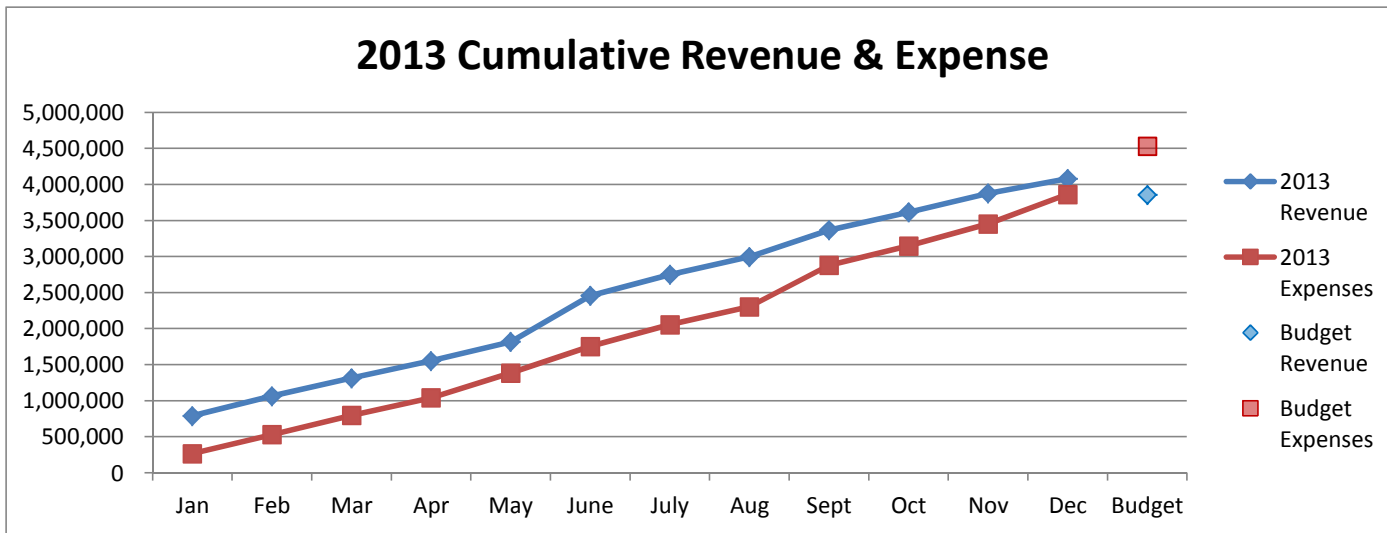
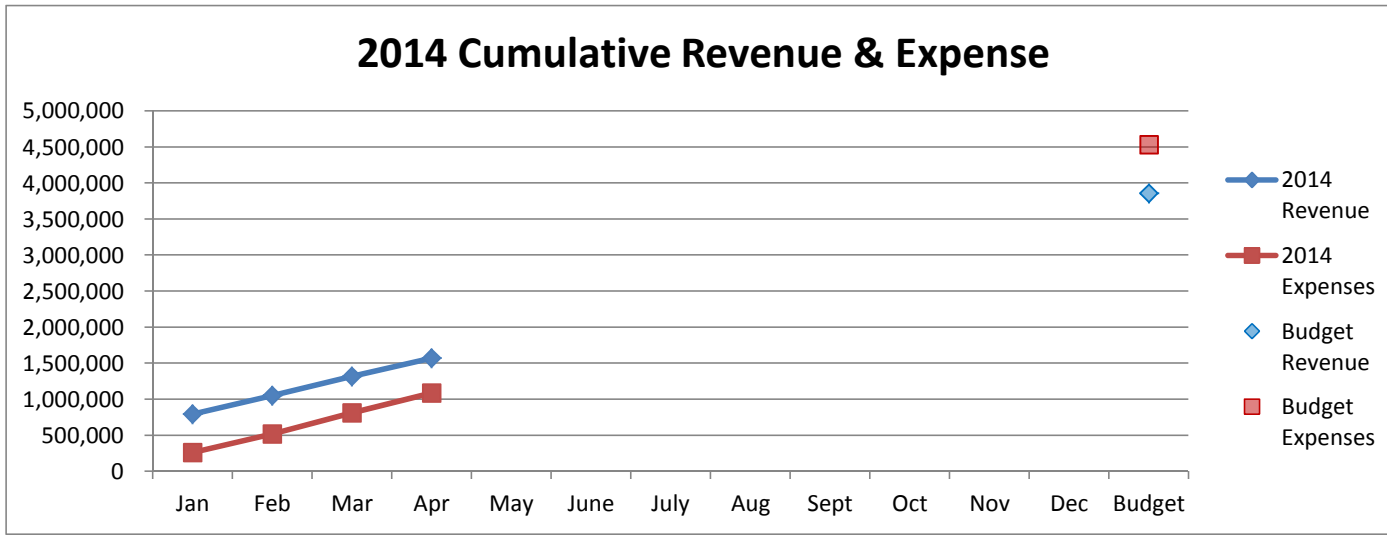

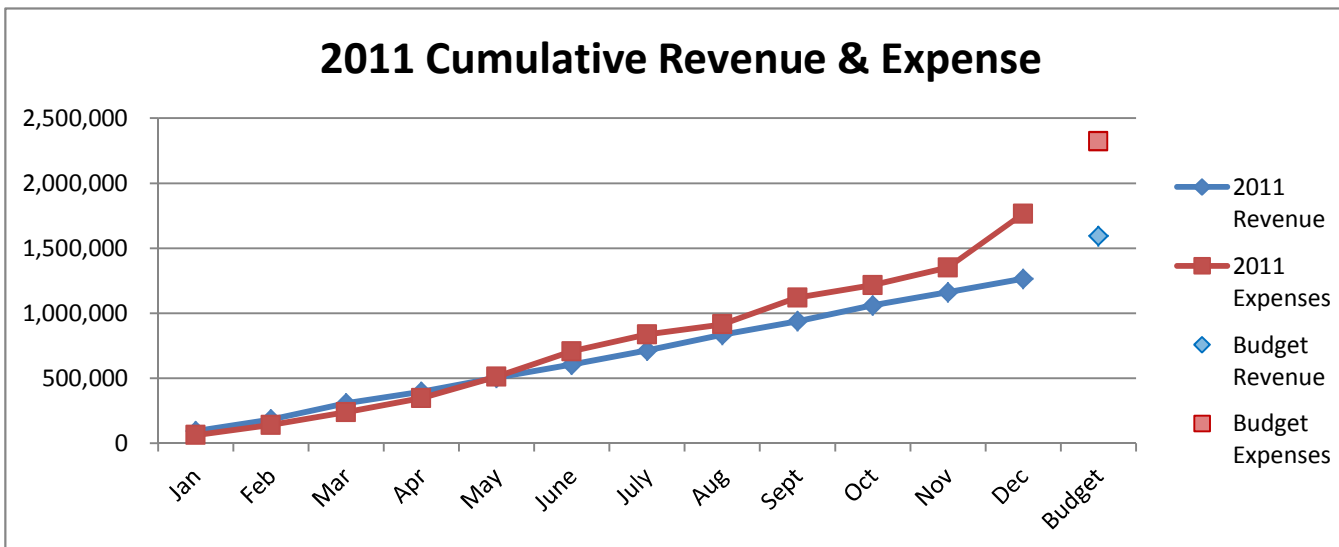
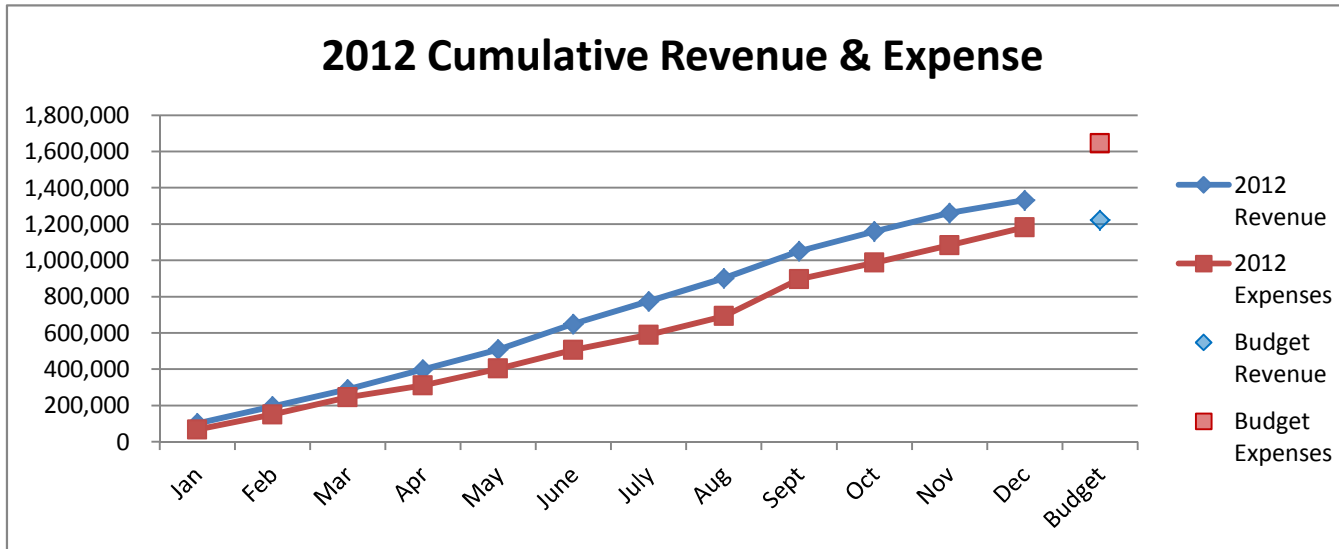

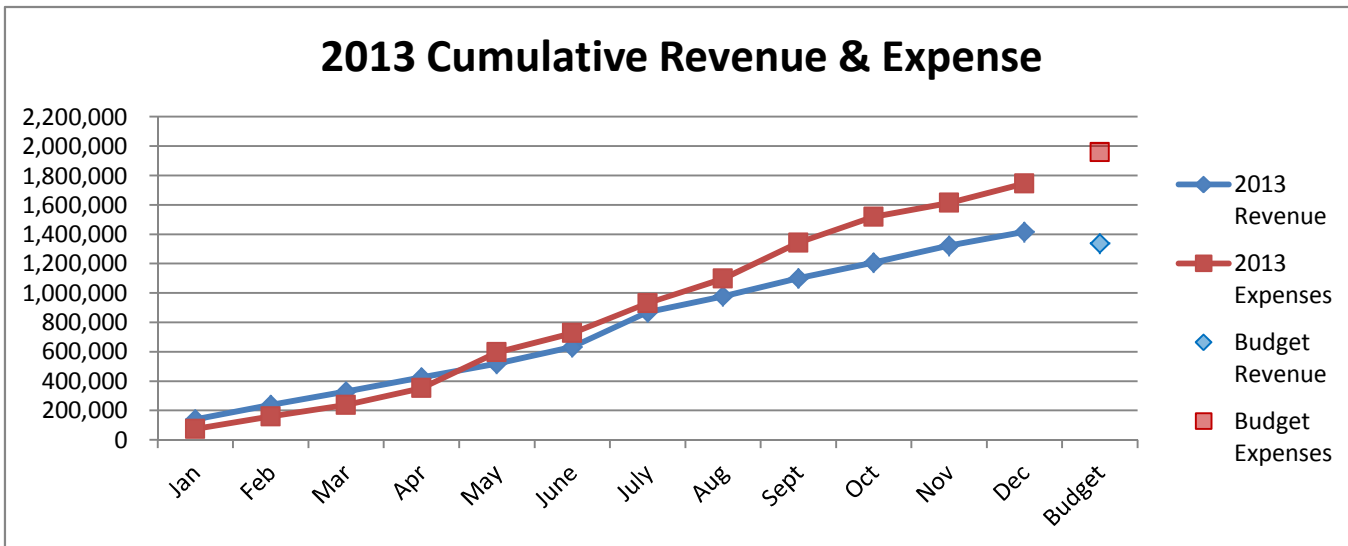
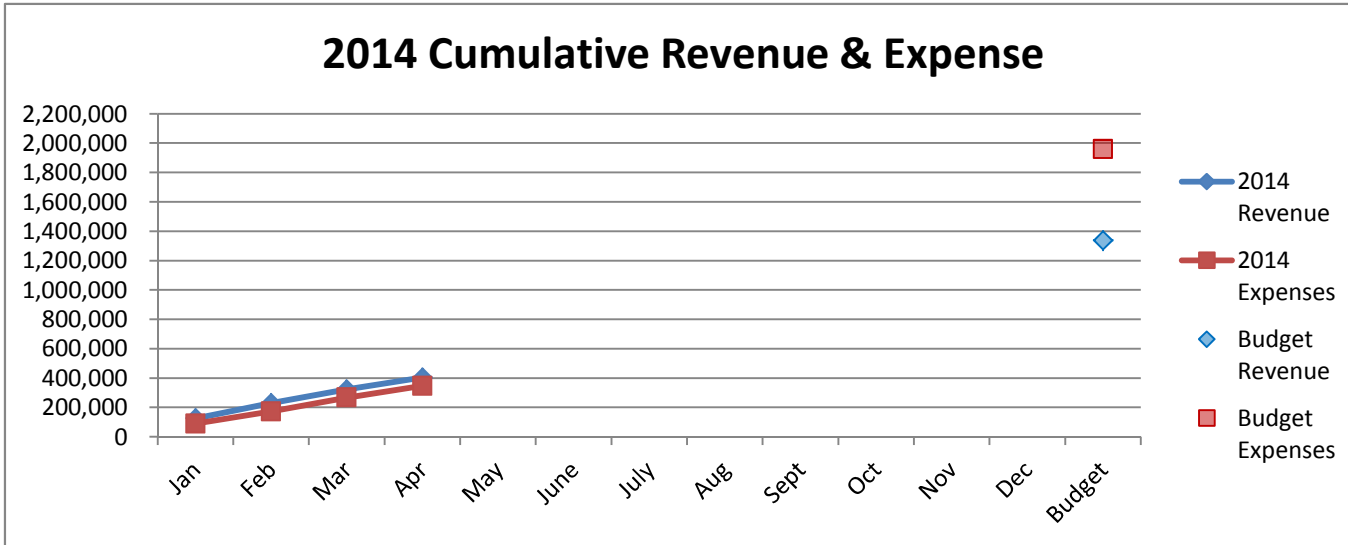
