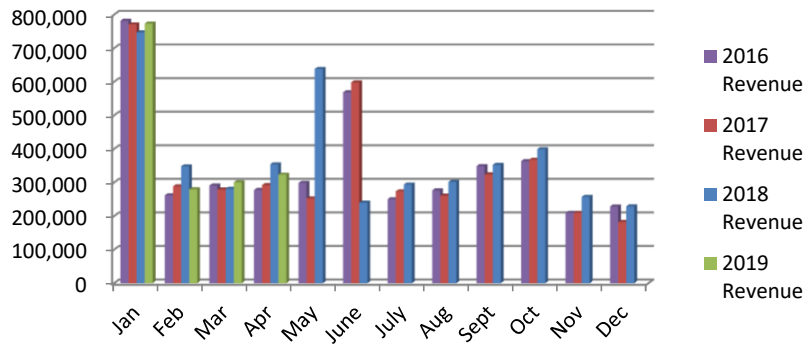

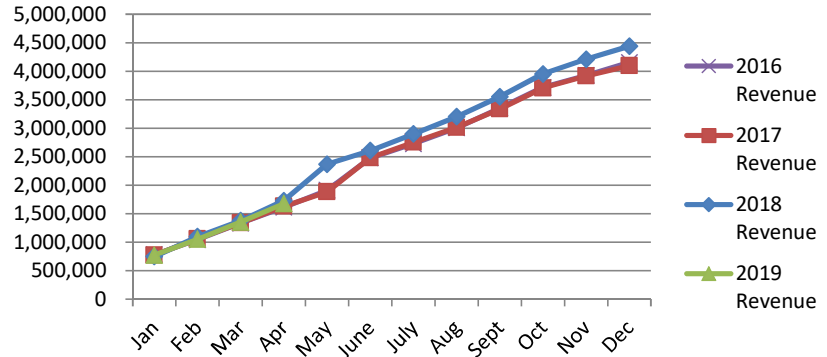

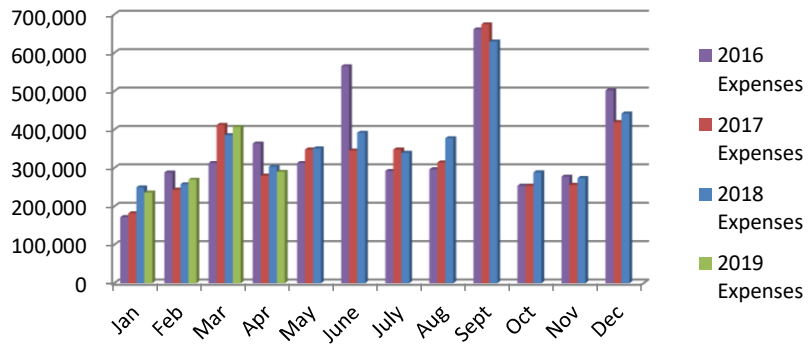
2016-2019 Revenue by Month



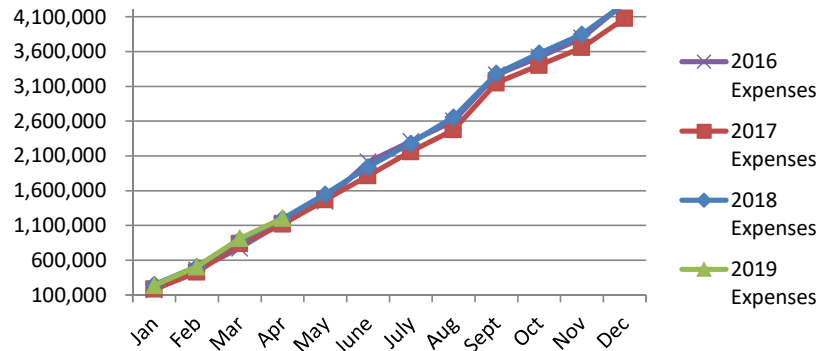
2016-2019 Cumulative Revenue



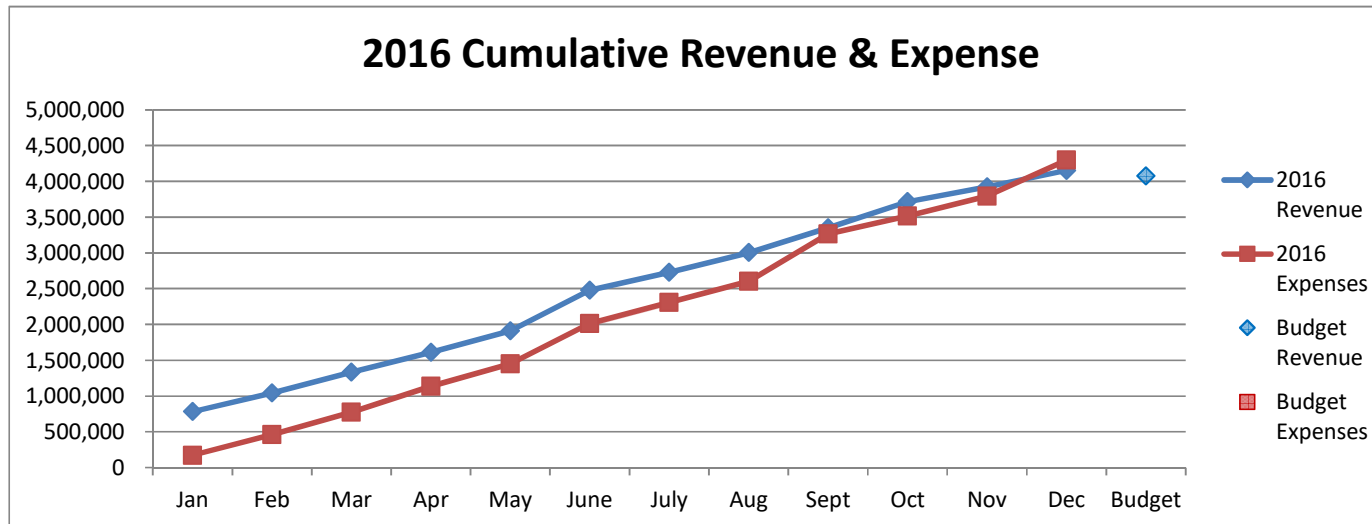
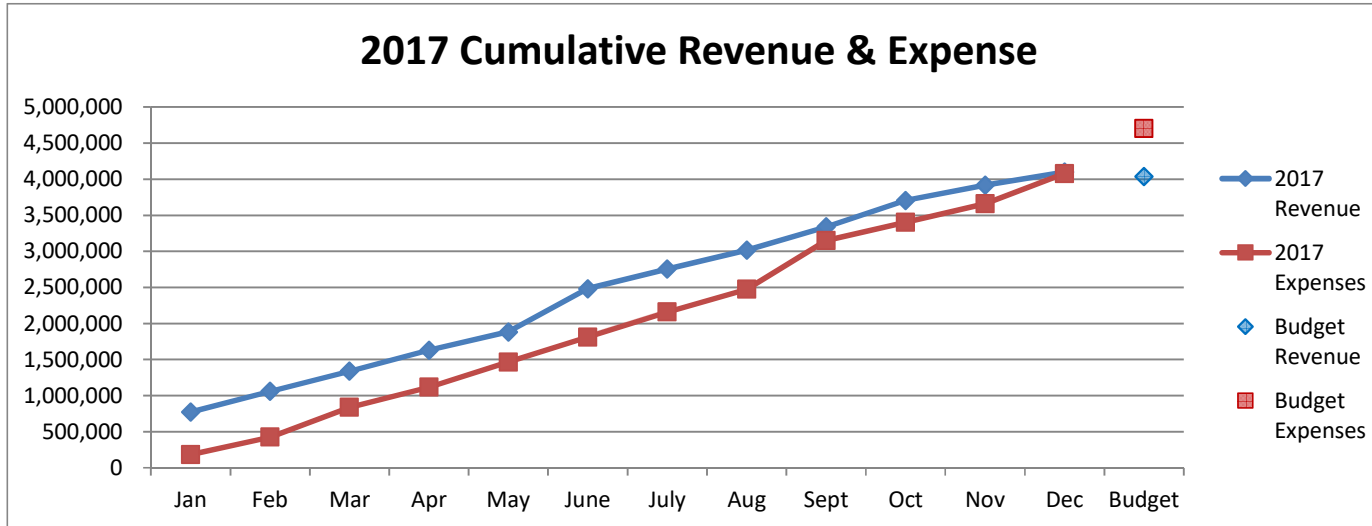
2016-2019 Expenses by Month



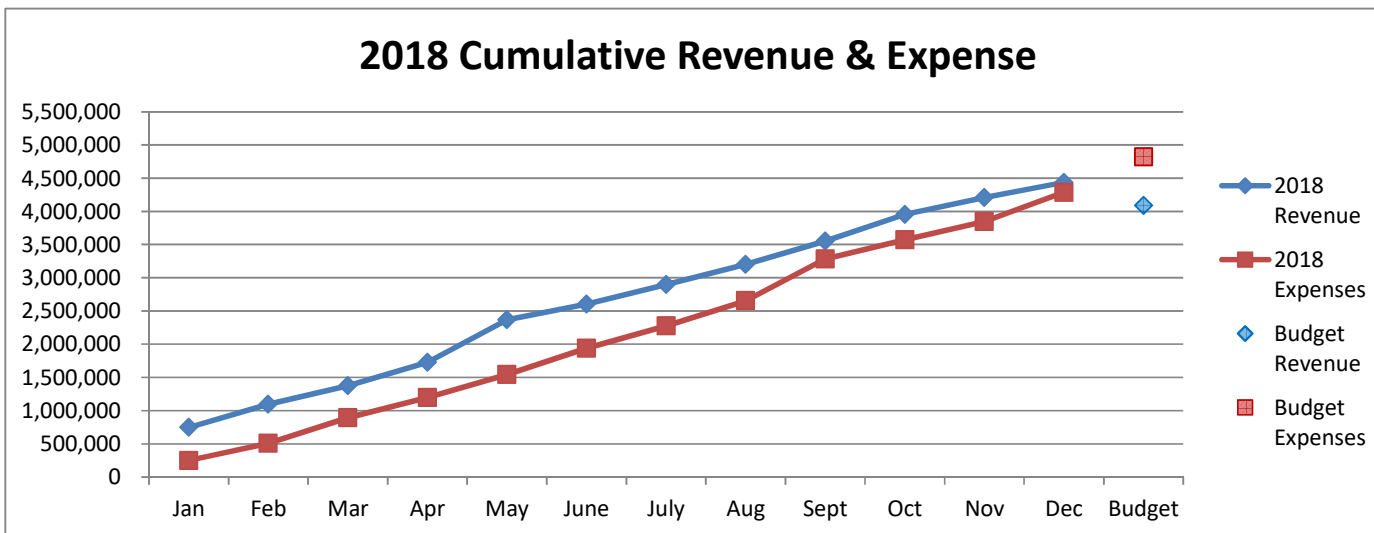
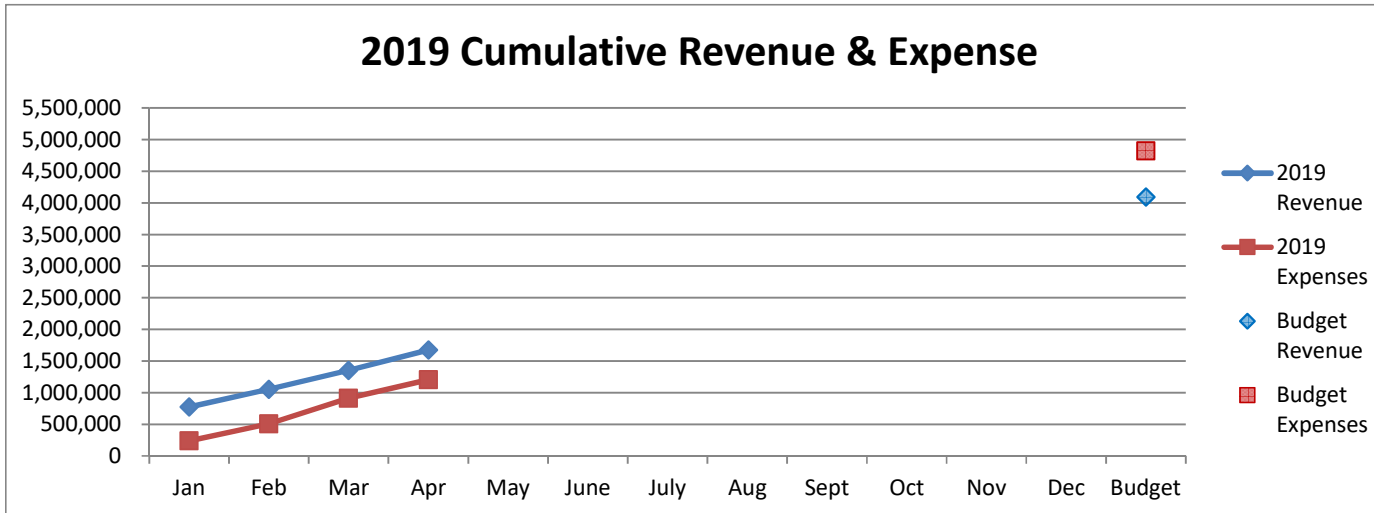
2016-2019 Cumulative Expenses

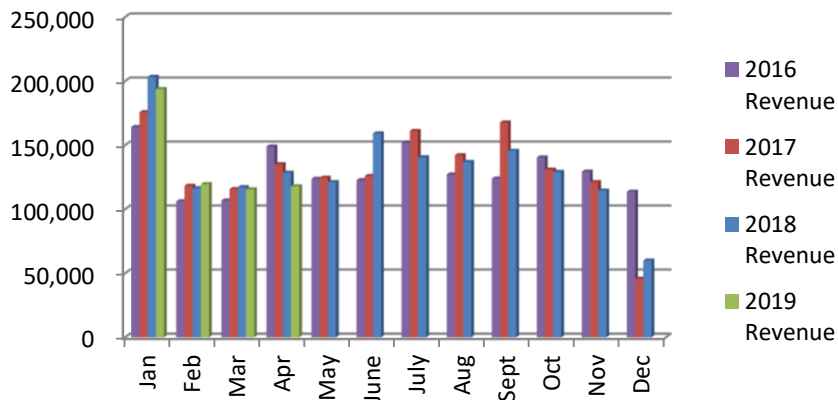

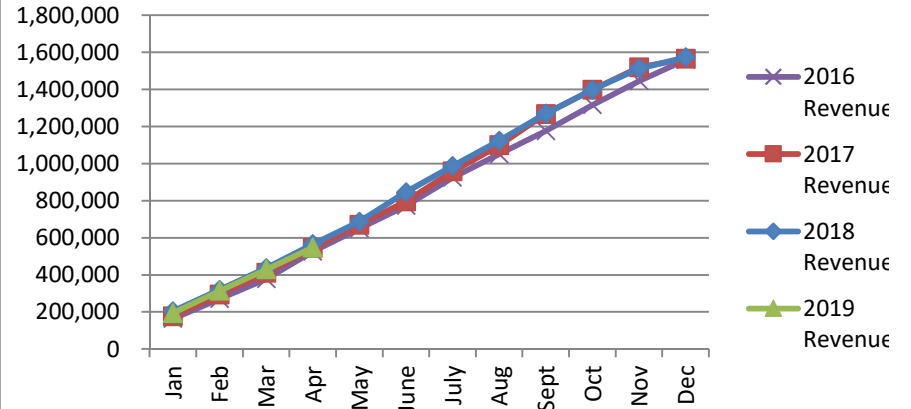

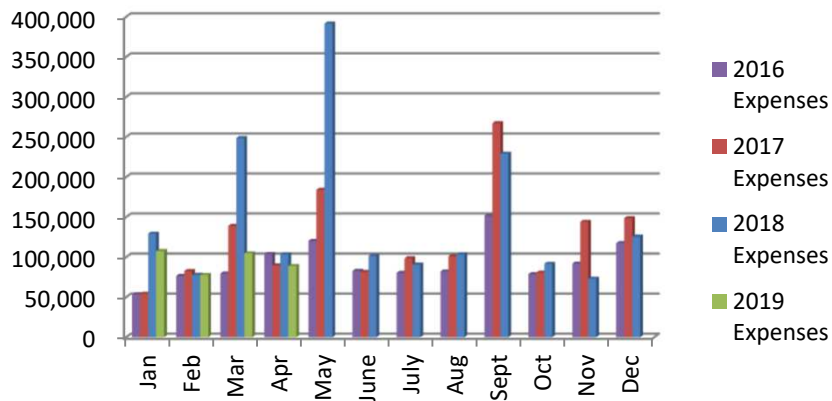
2016-2019 Revenue by Month



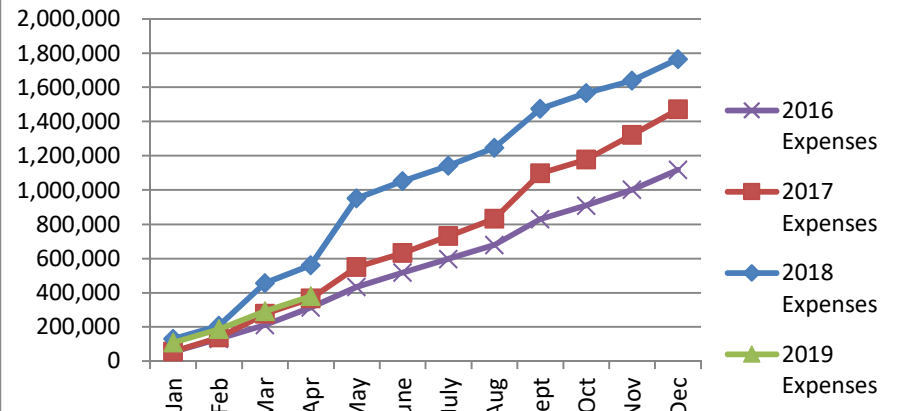
2016-2019 Cumulative Revenue



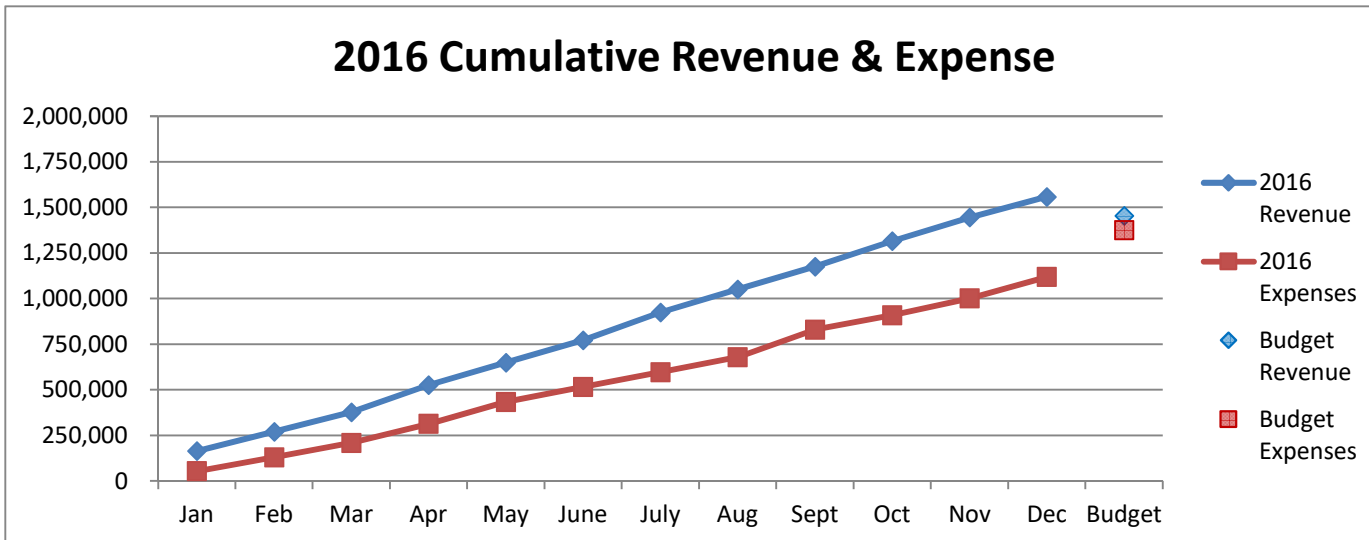
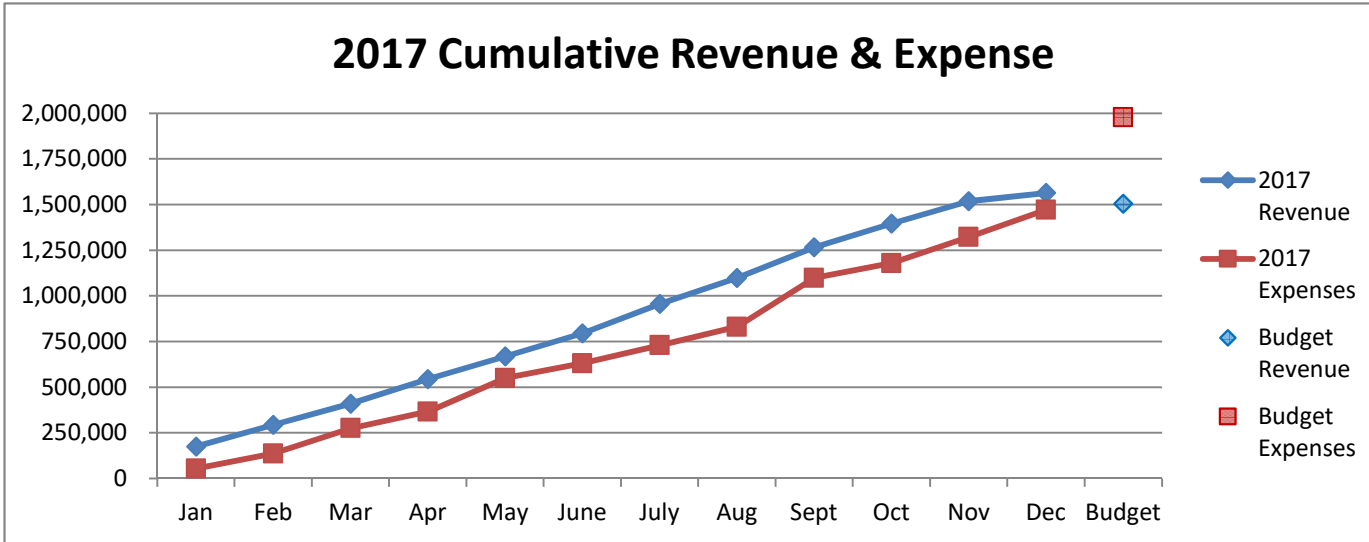
2016-2019 Expenses by Month



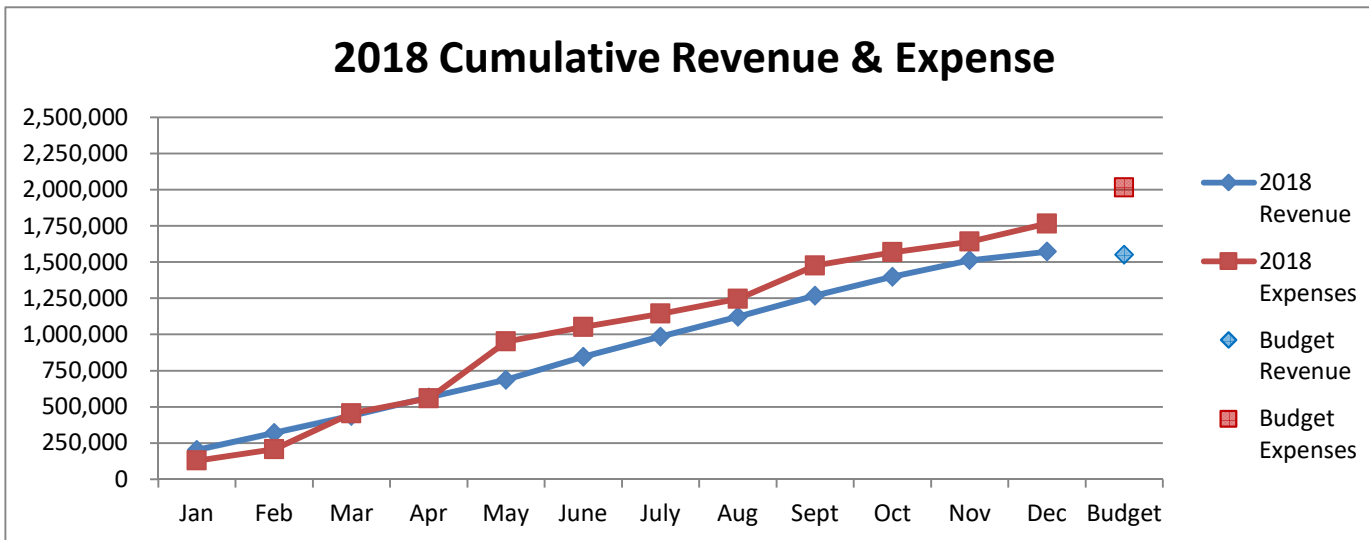
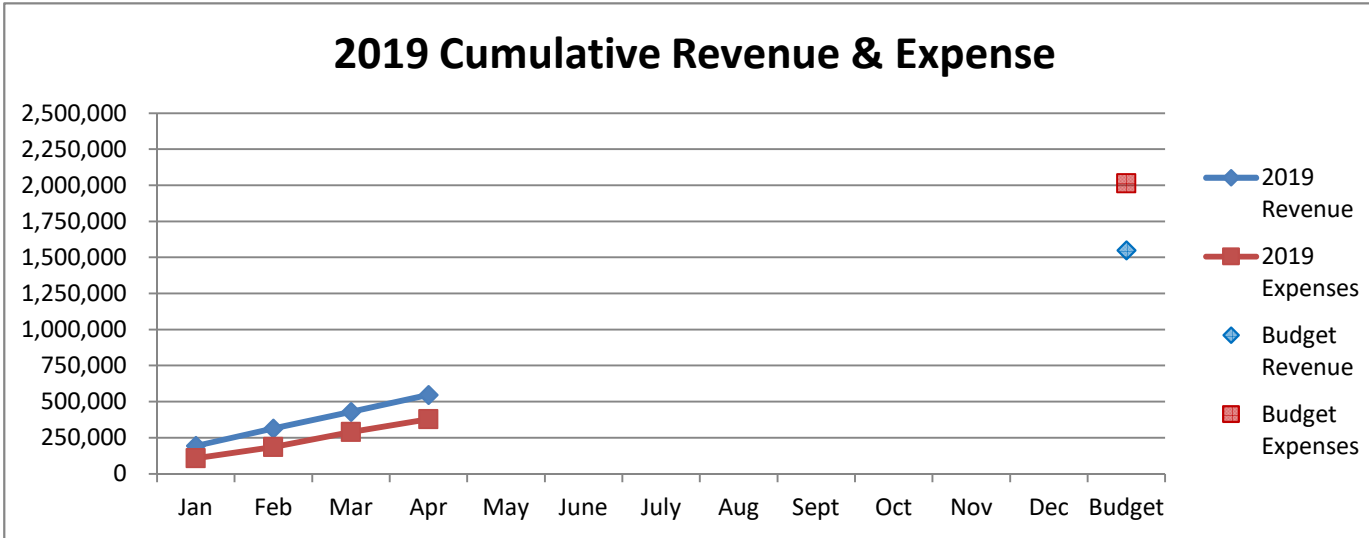
