#### PERMIT IS VALID FROM JANUARY 1ST THROUGH DECEMBER 31ST Please KEEP this PAGE for future reference

- 1. The dog park is for the use and enjoyment of Grosse Ile Township Dog Park permit holders only.
- 2. Dogs at the park must be healthy, fully vaccinated (Rabies, DHLP and Bordatella), dewormed, licensed and wearing identification tags.
- 3. Owners are legally responsible for their dogs and any injuries caused by their dogs.
- 4. Dog owners must remain with their dogs in the fenced area and must keep their dog in sight at all times.
- 5. Dog owners must carry a leash.
- 6. Dogs showing aggressiveness toward people or other dogs must be immediately leashed and removed from the dog park.
- 7. Dogs in heat or pregnant are not allowed in the dog park.
- 8. No more than two dogs per owner are allowed in the dog park at the same time.
- 9. Puppies using the dog park must be older than four (4) months.
- 10. Owners must clean up and dispose of feces deposited by their dog.
- 11. Dogs must be leashed prior to and upon leaving the dog park.
- 12. The dog park exercise area is for the use and enjoyment of dogs and their owners. Recreational use by others is not permitted.
- 13. No smoking or eating while in the exercise area.
- 14. Violators of rules for use of the park are subject to removal from the park, suspension or revocation of the dog park permits.
- 15. Professional dog trainers may not use this facility in the conduct of their business.
