Proposal: project action for 1) a Site Plan Review to construct fourteen residential dwelling units in a three-building affordable housing project under the multifamily infill provisions of LMC 18.13 and 2) a Variance to eliminate the 4-foot landscaping strip required by LMC 18.13.040.B and instead landscape and plant trees in the 8-foot side yard setback on DeBruyn Ave and the 10-foot front yard setback on 2nd St between the buildings and the sidewalk.

The written notice of appeal, together with the required appeal fee, must be filed prior to 4:30 p.m. on the last day of the applicable time period for appealing; provided, however, that if City Hall is not open on the last day of the applicable appeal time period, then the appeal period shall be extended until 4:30 p.m. on the next day in which City Hall is open. This SEPA determination does not constitute approval of the proposal.
