

RESOLUTION 23-04
For Land And Water Conservation Fund Application LW23-0032
For Stony Creek Ravine Nature Park Access Improvements

At a special meeting of the Charter Township of Oakland Parks and Recreation Commission held on Thursday March 23, 2023 the following Resolution was moved by Commissioner Dan Simon and seconded by Commissioner Brian Blust:

WHEREAS, the Charter Township of Oakland Parks and Recreation Commission supports the submission of an application titled, "Stony Creek Ravine Nature Park Access Improvements" to the Land And Water Conservation Fund grant program for the development of a Parking Lot, Trailhead and Trail System at Stony Creek Ravine Nature Park including the following universally accessible amenities consisting of a parking lot with bioswale, multi-use trail system with seating area on Stony Creek and connection to Stony Creek Metropark trails, trailhead facilities including picnic area, well for potable water, and enclosure for portable toilets; wayfinding/interpretive signage, and native plantings,

WHEREAS, the proposed application is supported by the Community's 5-Year Approved Parks and Recreation Plan; and,

WHEREAS, Charter Township of Oakland is hereby making a financial commitment to the project in the amount of \$340,200 matching funds, in cash and/or force account; and,

WHEREAS, if the grant is awarded the applicant commits its local match and donated amounts from the following sources:

Oakland Township Force Account Labor and Materials	\$33,300
Oakland Township Land Preservation Millage Funds	\$256,900
<u>Community Foundation for Southeast Michigan Legacy Design and Access Grant</u>	<u>\$50,000</u>
Total	\$340,200

NOW THEREFORE, BE IT RESOLVED that Charter Township of Oakland Parks and Recreation Commission hereby authorizes submission of a Land and Water Conservation Fund grant Application for \$340,100, and further resolves to make available a local match through financial commitment and donation(s) of \$ 340,200 (50%) of a total \$680,300 project cost, during the 2024-2026 fiscal years.
