

**RESOLUTION NO. 52-2021**

**INTRODUCED BY: MAYOR JAMES P. GRAVEN AND COUNCIL AS A WHOLE**

**A RESOLUTION AUTHORIZING A CONTRACT WITH THE CUYAHOGA COUNTY GENERAL HEALTH DISTRICT FOR THE PUBLIC HEALTH SERVICES TO BE RENDERED DURING THE YEARS 2022 AND 2023 AND TO DIRECT THE CUYAHOGA COUNTY FISCAL OFFICER TO CREDIT THE CONSIDERATION PAYABLE UNDER SAID CONTRACT AND TO DEDUCT EQUIVALENT SUMS FROM TAX SETTLEMENTS DUE THE CITY OF OLMSTED FALLS AND DECLARING AN EMERGENCY**

**WHEREAS**, the Cuyahoga County General Health District performs essential health services for all communities of Cuyahoga County, including the City of Olmsted Falls, Ohio; and

**WHEREAS**, the cost per capita for the year 2021 is \$6.00 and the cost per capita for the year 2023 is \$6.60, with the cost of such services paid by all participating subdivisions on a per capita basis, based on current population estimates. Now therefore,

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, CUYAHOGA COUNTY, STATE OF OHIO, THAT:**

**SECTION 1.** The Mayor is hereby authorized and directed to enter into a contract for public health services with the Cuyahoga County General Health District for the calendar years 2022 and 2023, a copy of said contract being attached hereto, marked Exhibit "A", and incorporated herein as if fully rewritten.

**SECTION 2.** The Fiscal Officer of Cuyahoga County is hereby directed to credit the District Health Fund of Cuyahoga County the sum of Fifty-One Thousand Four Hundred Ninety-Two Dollars (\$51,492.00) for calendar year 2022 and by deducting said amount from regular tax settlements to be made for the City of Olmsted Falls during the year 2022 in two (2) semi-annual installments of Twenty-Five Thousand Seven Hundred Forty-six Dollars (\$25,746.00) each.

**SECTION 3.** The Fiscal Officer of Cuyahoga County is hereby directed to credit the District Health Fund of Cuyahoga County the sum of Fifty-Six Thousand Six Hundred Forty-One Dollars (\$56,641.00) for calendar year 2023 and by deducting said amount from regular tax settlements to be made for the City of Olmsted Falls during the year 2023 in two (2) semi-annual installments of Twenty-Eight Thousand Three Hundred Twenty Dollars and Fifty Cents (\$28,320.50) each.

**SECTION 3.** The Clerk of Council is hereby authorized and directed to certify a copy of this Resolution to the Cuyahoga County Auditor immediately upon its passage.

**SECTION 4.** That this Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this

Council, and that deliberations of this Council and its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 5.** This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of Olmsted Falls for the reason that the subject contract must be executed in order to provide continuing public health services within the City of Olmsted Falls, Ohio. It shall therefore take effect immediately upon passage by the affirmative vote of not less than five (5) members elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law.
