

RESOLUTION NO. 01-2022

INTRODUCED BY: Council as a Whole

A RESOLUTION APPOINTING ANGELA MANCINI TO THE POSITION OF CLERK OF COUNCIL IN THE CITY OF OLMSTED FALLS, AND DECLARING AN EMERGENCY

WHEREAS, in accordance with Article V, Section 5.01(c), of the Charter of the City of Olmsted Falls, Council shall appoint a Clerk of Council after the commencement of each Council term; and

WHEREAS, the current Council term began on January 1, 2022; and

WHEREAS, this Council has determined to appoint Angela Mancini to the position of Clerk of Council for the Council term beginning January 1, 2022, and ending January 1, 2023. Now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, OHIO, THAT:

SECTION 1. The Council of the City of Olmsted Falls hereby appoints Angela Mancini to the position of Clerk of Council for the Council term beginning January 1, 2022 and ending January 1, 2023.

SECTION 2. This Council determines that, pursuant to Article V, section 5.01 (c) of the City Charter, Angela Mancini shall serve as Clerk of Council until January 1, 2023, or until her successor is appointed and qualified, unless she is removed from office in accordance with said section.

SECTION 3. The compensation for such services shall be at the annual rate set by Council.

SECTION 4. The aforesaid appointment is subject to periodic performance evaluations and, in any event, the continuation of such appointment shall be at Council's sole discretion, in accordance with the City Charter.

SECTION 5. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 6. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of Olmsted Falls for the reason that it is necessary that the aforesaid legislation be enacted without delay in order to provide for the orderly and efficient operation of the activities of City Council. Therefore, this Resolution shall therefore take effect

immediately upon passage by the affirmative vote of not less than five (5) members elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law.
