

ORDINANCE NO. 32-2023

INTRODUCED BY: MAYOR JAMES GRAVEN

AN ORDINANCE AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY OF OLMSTED FALLS, TO ENTER INTO AN INTERAGENCY AGREEMENT WITH THE OLMSTED FALLS SCHOOL DISTRICT FOR A SCHOOL RESOURCE/DARE/COMMUNITY LIAISON OFFICER AND DECLARING AN EMERGENCY

WHEREAS, the City Administration and Police Department agree to provide the Olmsted Falls School District with a full time School Resource/DARE/Community Liaison officer; and

WHEREAS, the City and Olmsted Falls School District agree to split the costs of said School Resource/DARE/Community Liaison Officer at a 50% level for the period of August 21, 2023 through June 5, 2024, as set for Exhibit “A”; and

WHEREAS, the City agrees to be responsible for the financial share of the officer after the school year is over up to the start of the new school year. Now therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, CUYAHOGA COUNTY, STATE OF OHIO, THAT:

SECTION 1. The Mayor be and is hereby authorized and directed to enter into a School Resource/DARE/Community Liaison Officer Interagency Agreement, with the Olmsted Falls School District in the form attached hereto as Exhibit “A” and made a part hereof.

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of the City of Olmsted Falls for the reason that the services provided herein are needed for the upcoming school year and, therefore, this Ordinance shall be effective immediately upon the affirmative vote of not less than five (5) members elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law.
