

RESOLUTION NO. 33-2023

INTRODUCED BY: MAYOR JAMES GRAVEN AND COUNCIL AS A WHOLE

A RESOLUTION RATIFYING THE SUBMISSION OF AN APPLICATION ON BEHALF OF THE CITY OF OLMSTED FALLS TO PARTICIPATE IN A GRANT FROM THE CUYAHOGA COUNTY DIVISION OF SENIOR AND ADULT SERVICES FOR THE CONTRACT PERIOD OF JANUARY 1, 2024 THROUGH DECEMBER 31, 2025 AND IF AWARDED, ACCEPTING SUCH GRANT, AND DECLARING AN EMERGENCY

WHEREAS, the City has been advised by the Division of Senior and Adult Services for the County of Cuyahoga that it is eligible to participate in a competitive application process for awarding of a Community Social Services Program; and

WHEREAS, the city is permitted to submit one application, with the total amount of the request not exceeding \$40,000 with a possible contract extension for up to one year; and

WHEREAS, the City of Olmsted Falls desires to participate in the 2024 Division of Senior and Adult Services Community Social Services Program through Cuyahoga County, and said application was submitted by the City on July 14, 2023; and

WHEREAS, the City has determined it is in the best interests of the community to ratify the submission of said Community Social Services Program grant funds for the development of activities for residents of the City who are age 60 and over or ages 18 to 59 with a disability, emphasizing programs and services that will effectively engage these residents who might not otherwise participate in programming. Now therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, CUYAHOGA COUNTY, STATE OF OHIO, THAT:

SECTION 1. The application for the 2024 Division of Senior and Adult Services Community Social Services Program through Cuyahoga County, submitted July 14, 2023, is hereby ratified and the Mayor is hereby authorized to accept said funds, if awarded, in accordance with the terms of the Grant Program on behalf of the City.

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of Olmsted Falls for the further reason that the deadline for the submission of the Grant Application is July 17,

2023. Therefore, this Resolution shall take effect immediately upon the passage by the affirmative vote of not less than five members elected to Council and approval by the Mayor, or otherwise at the earliest time allowed by law, whichever is later.
