

**ORDINANCE NO. 36-2023**

**INTRODUCED BY: MAYOR JAMES P. GRAVEN**

**AN ORDINANCE APPROPRIATING FUNDS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF OLMSTED FALLS, OHIO, FOR THE PERIOD COMMENCING JANUARY 1, 2023 AND ENDING DECEMBER 31, 2023 AMENDING ORDINANCES 56-2022 & 24-2023, AND DECLARING AN EMERGENCY**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, OHIO, THAT:**

**SECTION 1.** To provide for the current expenses and other expenditures of the City of Olmsted Falls for the period commencing January 1, 2023 and ending December 31, 2023, the sums set forth in Exhibit “A” (2023 Appropriations – Amendment #2) attached hereto and incorporated herein as if fully rewritten, are hereby appropriated for current expenses and other expenditures of the City for the Year 2023, and Ordinance 56-2022 & 24-2023 are hereby amended.

**SECTION 2.** The Director of Finance is hereby authorized and directed to expend the funds herein appropriated for the purpose of paying operating expenses of the City for the fiscal year ending December 31, 2023 and to make the necessary entries on the accounting records of the City to reflect the appropriations, cash advances and/or cash transfers between funds herein authorized to properly balance the various funds of the City.

**SECTION 3.** The Director of Finance is further authorized and directed to forward a certified copy of this Ordinance to the Office of the Cuyahoga County Budget Commission immediately upon its passage and signature of the Mayor.

**SECTION 4.** The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 5.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of Olmsted Falls for the reason that this Ordinance affects the day-to-day business of the municipality. It shall therefore take effect immediately upon passage by the affirmative vote of no less than five (5) members elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law.
