

ORDINANCE NO. 03-2024

INTRODUCED BY: MAYOR JAMES GRAVEN

AN ORDINANCE AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY OF OLMSTED FALLS, TO ENTER INTO A CONSULTING AGREEMENT WITH BUR OAK, LLC FOR PROFESSIONAL SERVICES RELATED TO ARBORIST DUTIES AND DECLARING AN EMERGENCY

WHEREAS, the Mayor desires to confirm the appointment of Alan Siewert of Bur Oak, LLC as the City Arborist; and

WHEREAS, Alan Siewert is a Board Certified Master Arborist and Municipal Specialist with many years of expertise in the field to serve the City; and

WHEREAS, the City agrees to compensate Bur Oak, LLC for City Arborist needs at a rate consist with the Agreement attached as Exhibit “A”; and

WHEREAS, Mr. Siewert will perform arborist duties, when necessary, as directed by the Service Director for the City. Now therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, CUYAHOGA COUNTY, STATE OF OHIO, THAT:

SECTION 1. The appointment of Bur Oak, LLC and Mr. Alan Siewert will be effective January 1, 2024 through December 31, 2026.

SECTION 2. The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of the City of Olmsted Falls for the reason that the services provided herein are needed for the current operation of the City government and, therefore, this Ordinance shall be effective immediately upon the affirmative vote of not less than five (5) members elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law.
