

RESOLUTION NO. 09-2024

INTRODUCED BY: COUNCIL AS A WHOLE

A RESOLUTION DETERMINING TO REVERSE THE DECISION OF THE OLMSTED FALLS ARCHITECTURAL BOARD OF REVIEW WITH REGARD TO THE REQUEST OF BRIAN MAURER TO INSTALL VINYL SIDING AT THE RESIDENTIAL PROPERTY LOCATED AT 7769 COLUMBIA ROAD, CUYAHOGA COUNTY PERMANENT PARCEL NO. 281-19-022, AND DECLARING AN EMERGENCY

WHEREAS, the City's Architectural Board of Review (ABR) was created, organized and exists in accordance with Section 1206.04 and Chapter 1444 of the Codified Ordinances, and its powers and duties are set out in Section 1206.04 and Section 1444.04 of the Codified Ordinances; and

WHEREAS, the establishment of the City's Historic Area Conservation District is provided in Chapter 1262 of the Codified Ordinances; and

WHEREAS, both Chapter 1262 and Chapter 1444 provide that, before a permit for any exterior alteration may be issued by the City's Building Department, the request must be reviewed by the ABR; and

WHEREAS, Brian Maurer has requested that he be permitted to install vinyl siding at the residential property located at 7769 Columbia Road, Cuyahoga County Permanent Parcel Number 281-19-022; and

WHEREAS, on December 14, 2023 the ABR voted to deny issuing a Certificate of Appropriateness to Brian Maurer to permit him to install vinyl siding at his residential property in accordance with Section 1444.05 of the Codified Ordinances; and

WHEREAS, the denial of the Certificate of Appropriateness was appealed to City Council by letter dated December 28, 2023; and

WHEREAS, pursuant to the Codified Ordinances a Special Council Meeting was convened on January 30, 2024; and

WHEREAS, Brian Maurer was present and permitted to present arguments and contentions in support of the request in the form of sworn testimony and documentation introduced as exhibits; and

WHEREAS, the ABR also presented evidence supporting its decision in the form of sworn testimony and documentation introduced as exhibits to assist this Council in reviewing the request; and

WHEREAS, members of the public were also presented with the opportunity to provide sworn testimony on the issue; and

WHEREAS, this Council has reviewed the record, the testimony presented at the Special Meeting and the exhibits introduced at the Special Meeting and thereafter, and has determined to reverse the decision of the ABR. Now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, CUYAHOGA COUNTY, OHIO, THAT:

SECTION 1. This Council determines to reverse the decision of the City’s Architectural Board of Review made on December 14, 2023 with regard to the request of Brian Maurer for a Certificate of Appropriateness permitting him to install vinyl siding at his residential property located at 7769 Columbia Road, Cuyahoga County Permanent Parcel Number 281-19-022.

SECTION 2. This Council hereby directs the Architectural Board of Review to issue to Brian Maurer a Certificate of Appropriateness, in accordance with Chapter 1444 of the Codified Ordinances, to permit him to install vinyl siding at his property located at 7769 Columbia Road, Cuyahoga County Permanent Parcel Number 281-03-004.

SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of Olmsted Falls for the reason that the decision by Council as to the request should be made as soon as possible. Therefore, this Resolution shall therefore take effect immediately upon the passage by the affirmative vote of not less than five members elected to Council and approval by the Mayor or otherwise at the earliest time allowed by law.
