

**ORDINANCE NO. 33-2024**

**INTRODUCED BY: Mayor James Graven**

**AN ORDINANCE APPOINTING TOM REYNOLDS AS FINANCE DIRECTOR AND TAX ADMINISTRATOR FOR THE CITY OF OLMSTED FALLS, ESTABLISHING COMPENSATION, AND REPEALING ALL LEGISLATION INCONSISTENT HEREWITH**

**WHEREAS**, Tom Reynolds meets all of the requirements of the Charter of the City to serve as the City’s Finance Director; and

**WHEREAS**, in Ordinance 12-2024 Council adopted a compensation range for the position of full-time Finance Director as \$75,000 to \$110,000; and

**WHEREAS**, the Mayor and Council desire to appoint Tom Reynolds’ professional services on a permanent full-time basis as the Finance Director for the City. Now Therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, CUYAHOGA COUNTY, OHIO, THAT:**

**SECTION 1.** This Council hereby confirms the Mayor’s appointment of Tom Reynolds as the Finance Director for the City effective June 12, 2024.

**SECTION 2.** Finance Director Reynolds shall be compensated at the annual salary rate of Ninety-Two Thousand Five Hundred Dollars (\$92,500.00) and that said position shall be full-time with fringe benefits.

**SECTION 3.** All prior legislation inconsistent with this legislation, in whole or in part, is hereby repealed to the extent necessary to avoid conflict with this Ordinance.

**SECTION 4.** The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 5.** This Ordinance shall take effect at the earliest time allowed by law.
