AN ORDINANCE AUTHORIZING THE MAYOR TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL **IMPROVEMENTS** AND/OR LOCAL TRANSPORTATION IMPROVEMENT **PROGRAMS** AND TO EXECUTE ALL REQUIRED, **AND** CONTRACTS AS **DECLARING** AN**EMERGENCY** 

**WHEREAS,** pursuant to Article VIII, Section 2(K) of the Ohio Constitution, the State of Ohio is authorized to issue bonds and other obligations of the State for the purpose of financing public infrastructure capital improvements of political subdivisions as designated by law; and

**WHEREAS**, pursuant to Section 164.06 of the Ohio Revised Code, the District One Public Works Integrating Committee has been created to accept, evaluate and recommend applications for state financing of capital infrastructure improvement projects of political subdivisions in Cuyahoga County; and

**WHEREAS**, pursuant to Section 164.05 of the Revised Code, the Ohio Public Works Commission ("OPWC") has been created to accept and approve applications for state financing of capital infrastructure improvement projects of political subdivisions in Cuyahoga County; and

**WHEREAS**, the infrastructure improvement herein above described herein is considered to be a priority need for the community and is a qualified project under the OPWC programs.

WHEREAS, it has been deemed in the best interest of the health, safety and welfare of all City of Olmsted Falls residents for the Mayor to prepare and submit an application to the Ohio Public Works Commission State Capital Improvements and/or Local Transportation Improvement Programs and, further, to authorize the Mayor to execute all contracts as may be required by OPWC. Now therefore,

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OLMSTED FALLS, CUYAHOGA COUNTY, OHIO, THAT:

**SECTION 1**. The Mayor is hereby authorized to prepare and submit an application to the Ohio Public Works Commission State Capital Improvements and/or Local Transportation Improvement Programs and, further, to authorize the Mayor to execute all contracts as may be required by OPWC for the purpose of designing and constructing:

**SECTION 2.** Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure for the immediate preservation of the health, safety and welfare of the residents of the City of Olmsted Falls for the further reason to allow for an application to be filed within the next thirty (30) days. Therefore, this Ordinance shall take effect immediately upon the affirmative vote of not less than five (5) members elected to Council, and signature by the Mayor, or otherwise at the earliest time allowed by law.
