

FIRST AMENDMENT

THIS FIRST AMENDMENT (the “Amendment”) is made and entered into May 6th, 2024, (the “Effective Date”), by and between Cuyahoga County, Ohio a body corporate and politic and a political subdivision of the State of Ohio organized and existing under the Charter of Cuyahoga County effective January 1, 2010, as same may have been amended, modified, and supplemented to the effective date hereof (the “County”) and on behalf of the Cuyahoga County Division of Senior and Adult Services (“DSAS”) and the following providers of services (hereinafter referred to as a “New Provider” or “Provider”):

WHEREAS, the County and several other Providers entered into a Master Contract on or about December 5, 2023 (the “Original Contract”) to provide specialized community center-based services from Providers to assist DSAS in providing an array of social services to seniors and at-risk residents of Cuyahoga County; and

WHEREAS, three additional Providers have been identified to provide similar services to seniors and at-risk residents of Cuyahoga County, Ohio; and

WHEREAS, pursuant to the Master Contract, the Parties agree that an Amendment to Add Provider requires execution only by the County and the New Provider in order to be effective. The Parties understand that an Amendment to Add Provider does not alter the terms of this Contract; and

WHEREAS, parties now desire to amend the Original Contract to add the above three Providers and add funds.

NOW, THEREFORE, in consideration of mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Original Contract is amended as follows:

1. This Amendment amends the Original Contract and, except as specifically amended hereby, the Original Contract shall remain in full force and effect. The Original Contract, together with this Amendment are herein collectively referred to as the “Contract.” In the event of a conflict between this Amendment and the Original Contract, as amended, the terms of this Amendment will prevail.
2. Section 1.4 of the Original Contract is amended to increase the total not to exceed amount by Two Million Eight Hundred Ninety-One Thousand Two Hundred Seventy-Six Dollars (\$2,891,276) for a total not to exceed amount of Eight Million Nine Hundred Fifty-Five Thousand Thirty-Eight Dollars (\$8,955,038).
3. Exhibits A through DD are hereby amended to add Exhibit EE, titled Catholic Charities Corporation on behalf of Good Sheperd Family Center, for this term. Said Exhibit EE is attached hereto and incorporated herein as if fully rewritten.

4. Exhibits A through DD are hereby amended to add Exhibit FF, titled City of Bedford Heights, for this term. Said Exhibit FF is attached hereto and incorporated herein as if fully rewritten.

5. Exhibits A through DD are hereby amended to add Exhibit GG, titled The Mandel Jewish Community Center of Cleveland, for this term. Said Exhibit FF is attached hereto and incorporated herein as if fully rewritten.

SEVERAL OTHER PROVIDERS ENTERED INTO A MASTER CONTRACT ON OR ABOUT ALSO AGREES ON BEHALF OF THE AFOREMENTIONED ENTITY AND PERSONS, TO BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.
