**CALL TO ORDER**

Moved by Dr. Laszlo supported by Mrs. Rimanelli that a student, whose identity is known to the Board, be expelled from the South Lyon Community Schools through no less than the first semester of the 2024-25 School Year.

During the term of the expulsion, the Student shall not be on District grounds or attend any District functions, whether they are held at District facilities or any other venue. This prohibition includes athletic events, performances, extracurricular activities, and co-curricular activities. The Student may not attend a non-school sponsored event that takes place on school property. If there are special circumstances, requests for written approval may be made to the Superintendent or his designee.

The Student may initiate a petition for reinstatement at any time after November 1, 2024 to petition for reinstatement, no earlier than the start of the second semester of the 2024-25 School Year, provided the Student meets the requirements set forth by the Board.
