During the time of the suspension, the student shall not be on school grounds or attend any functions involved with South Lyon Community Schools, whether they are held at South Lyon Community Schools or any other venue. This prohibition includes athletic events, performances, extracurricular activities, and co-curricular activities. The student may not attend a non-school sponsored event that takes place on school property. If there are special circumstances, requests for written approval may be made to the Superintendent or his designee.


