

**MINUTES OF THE SPECIAL MEETING

**CALL TO ORDER**

Mr. Schwegler called the May 9, 2024 Special Meeting to order at 6:18 p.m.

**ROLL CALL**

Vice-President Schwegler explained that the purpose of the meeting was for the Board to consider discipline of a student for alleged violation of the Board Policy 2006 Student Code of Conduct Threats and Board Policy 2006 Verbal Assault.

Introductions of board members, administration and family members were made.

Vice-President Schwegler briefly outlined the procedures of the hearing. Administration will present background information regarding the incident. The family will have the opportunity to share their perspective of the incident. The Board will question the family and the student to gather all the facts. The Board will discuss their findings privately. While still in closed session, the vice-president of the Board will provide a summary of the Board's discussion. The Board will return to open session to make their decision and to read a final resolution for the student.

Moved by Dr. Laszlo supported by Mr. Maguire that the student, whose identity is known to the Board, will be expelled from the District no less than the first semester of the 2024-25 School Year.

During the time of the expulsion from school, the Student shall not be on District grounds or attend any District functions, whether they are held at District facilities or any other venue. This prohibition includes athletic events, performances, extracurricular activities, and co-curricular activities. The student may not attend a non-school sponsored event that takes place on school property. If there are special circumstances, requests for written approval may be made to the Superintendent or his designee.


