The Student may enroll in the South Lyon Community Schools VLP Program for the second semester of 2022 provided the student meets the conditions set forth by the Board. Social probation will be implemented at the discretion of the Administration. Any further violations of the Code of Student Conduct will bring the Student back before the Board.

During the 2021-22 school year , the student shall not be on District grounds or attend any District functions, whether they are held at District facilities or any other venue. This prohibition includes athletic events, performances, extracurricular activities and co-curricular activities. The student may not attend a non-school sponsored event that takes place on school property. If there are special circumstances, requests for written approval may be made to the Superintendent or his designee.
