CALL TO ORDER

Moved by Ms. Urtel, supported by Mr. Abbate that a Student, whose identity is known to the Board, be suspended from the South Lyon Community Schools through the remainder of the 2021-22 school year. Any further violations of the Code of Student Conduct will bring the Student back before the Board.

During the time of this suspension, the student shall not be on District grounds or attend any District functions, whether they are held at District facilities or any other venue. This prohibition includes athletic events, performances, extracurricular activities and co-curricular activities. The student may not attend a non-school sponsored event that takes place on school property. If there are special circumstances, requests for written approval may be made to the Superintendent or his designee.

The Student may petition the Board for reinstatement no sooner than July 1, 2022 provided the Student meets the requirements set forth by the Board.
