


Information available for each property includes: Assessed Value, Property Tax Amount, Amount Paid, and Amount Due. This information is provided as a service to the public. All of the information available on the site is public record. You may also print your property tax receipt here.

2023 Final Tax Installment Due July 31, 2024, payments after August 7, 2024 should be made to the Milwaukee County Treasurer's Office.

12. The page will be redirected to the payment area. Click the type of payment that will be used and follow the instructions to finish payment.



A convenience fee of 2.55% (\$2.00 minimum) of the tax payment amount or \$3.95 for personal Visa debit is charged by Value Payment Systems for using this service. We accept Discover, MasterCard, Visa credit and debit cards and PayPal. The fee for echeck is \$1.50.

*Note: If you select credit and are using a debit card you will be charged the credit processing rate.
